Pots off the reefs bill

Reef Rescue is seeking support for another attempt to prohibit the fish traps on the artificial reef sites. Given all the recent attention surrounding the Saltwater Angler Registry and this being an election year, the NJ legislators are well aware of anglers as a voting block. If enough of us voice our support for Bills S-221 and A-1152, they may just sense it would be in their best interest to support these bills as well.

Catch Shares

This issue is gaining more momentum on both sides of the argument. Many Recreational anglers are opposed to the concept of selling fishing quotas to the highest bidder. Some Commercial fishermen see this as a serious threat to their livelihood.

Recently, The House of Representatives recently passed a bill that would prohibit Government funding for Catch Share research. We need everyone to contact their Federal legislators and let them know that Catch Shares is not good for New Jersey's fishing businesses.

RFA SUPPORTS "POTS OFF REEF" BILLS Removing Fixed Gear from Artificial Reefs Is Part of Larger Problem

March 27, 2011 - New Jersey legislation which would prohibit the use of fixed gear within 100 feet of artificial reefs created by the state Department of Environmental Protection (DEP) and their Division of Fish and Wildlife (Division) has successfully moved out of the Senate in a vote of 31-4. The Recreational Fishing Alliance (RFA) has supported "Pots Off Reef" legislation since originally introduced back in 2007, and continues to support those legislative efforts to protect the access rights of recreational anglers along New Jersey's artificial reef complex.

"We support getting the pots off the artificial reefs, we've never wavered in that view," said RFA executive director, Jim Donofrio, who explained that submerged trap lines and high fliers have adversely impacted access for all users. "This is definitely an access issue, and on that point the RFA supports both the senate bill (S221) and the assembly companion (A1152), as we always have," he said.

While RFA says the legislation would effectively eliminate gear conflicts on the state's artificial reefs and help improve recreational access, the organization has also warned of a bigger conservation issue that needs to be addressed. Since 2006, RFA has been bringing attention to the unmanaged commercial pot/trap fishery that has existed in New Jersey for many years, an issue they claim impacts not only the fishermen but the fish themselves.

"What we really want to know is just how many traps are out there to begin with, and that's an answer we're not getting," Donofrio said. "Other groups now starting to get involved in state fisheries are unaware of the history as it relates to species like blackfish and sea bass, and they've been quick to blame legislators when the state has had the power for many years to pass regulations consistent with the New Jersey Reef Plan that would prohibit all pots and traps from the reefs."

RFA believes that in addition to angler access, unaccounted fish traps present a serious conservation issue that must be also addressed, something Donofrio says "we've been requesting since long before these reef bills were introduced." In March of 2006, he sent an official welcome letter to then-incoming Division Director Dave Chanda, in which RFA brought attention to problems with the tautog (blackfish) stock along the coast.

"Discussions with NJ Division of Fish and Wildlife have indicated that the state does not have the adequate information to separate the percentage of blackfish directed fishing effort from all fish pot license holders," Donofrio wrote in 2006. "We encourage the state to determine the current number of legitimate pot fishermen targeting blackfish and the number of pots being fished. From this information, pot tags can be issued to ensure that all gear is removed during closures."

"Furthermore, we urge the state to require removal of all pots and enforce a no-sale/no-possession provision from June 1 through November 14. This will allow law enforcement to determine illegal points of sale such as restaurants and markets," he added.

RFA says the illegal and unreported landings and sale of tautog have been a persistent problem and perhaps the biggest driver of that stock's decline over the years, and the group has encouraged coastal states to address the seriousness of the issue with increased enforcement to address poaching issues and a stronger management state-by-state management plan to address fish pots and traps.

RFA's 2006 letter to division director Chanda also set a June 1, 2006 cutoff date for the state to initiate response or action, at which time Donofrio said "we will pursue stronger measures through the legislature." RFA is continuing to work with key coastal legislators on drafting language which will

address both access and conservation issues related to coastal fisheries management in New Jersey, and they're hoping that more tie-in from the coastal community can help put

"Every angler in New Jersey realizes that the current legislation does not have the support of New Jersey's commercial fishing community, which is why this pots bill has become such a political football in Trenton," said RFA-NJ chapter chairman, Adam Nowalsky. "Obviously, the commercial and recreational sector is not in agreement on getting pots off the reef, but the point we do all agree on is that the accountability issue with undocumented fish traps soaking in our coastal waters 365 days a year." An Atlantic County resident and charter boat captain, Nowalsky is also legislative proxy for New Jersey at the Atlantic States Marine Fisheries Commission (ASMFC).

According to Capt. Tony Bogan of the United Boatmen, the access and conservation issues surrounding New Jersey's pot management problem have been debated for years. "We've been pushing this issue at the state level for over a decade and have made countless recommendations on how to address the seriousness of the live market problem," he said. Bogan, who also represented the state of New Jersey as representative at the Mid Atlantic Fishery Management Council from 2003-2006, said the simple act of removing pots from the state reefs is part of a much bigger state issue.

"We have no idea how many pots are out there, but instead of addressing the serious management problem, individuals are allowing state legislators to battle over a bill that will essentially just spread illegal pots out over a bigger area," Bogan said. "Moving conflict from one place to another will not address the most serious fisheries issue we have on our reef fish."

RFA continues to support efforts to get all fixed gear off New Jersey's artificial reef complex, both along inshore state waters and outside the 3-mile limit in federal waters, but without a true management plan to follow, RFA believes the current legislation is mostly symbolic. "A simple executive order from the Governor can get those pots off the reef next week, and when you look at the final reef program, the DEP has the legal means to comply," Donofrio said.

"We've done our due diligence on this legislation, and RFA is going to have to ask our legislators for more help in dealing with both access and conservation issues along the coast," Donofrio said.

FISHING REPORT by Joe Filice

Flew into Ft Myers on Weds the 9th. Woke up on Thursday to torrential rain and thunder showers, so Thurs was spent donating money to the Seminole Indians at their casino in Imocalee.

On Friday we woke to 25 mph winds out of the northwest, but decided to try to find some shelter and fish the bays around the Big Carlos Pass in Fort Myers, where my friend's boat is kept. The bay had white caps and the water temp had dropped from 74 degrees on Tuesday to 66 degrees. We were unable to get any decent drifts and finally found a semisheltered cove and anchored up. I had a decent size spotted sea trout, but lost it at the boat. I landed a nice red fish & a 16" Sheepshead which were released. All caught on a jig tipped with shrimp.

On Saturday the winds were down to 10 mph out of the northeast and we hit the water around 10:00 am. Thought it would be a banner day as I hooked and landed 18" spotted sea trout on each of the first two casts. Again using a jig w/shrimp suspended under a float. That fast, the fish shut down and we had only a few shorts the rest of the day, but the day was not lost. While drifting the grass flats we had 5 manatee circling the boat and three dolphin feeding in 3' of water. Very relaxing and nice day on the water.

On Sunday, my old boss, who's home and boat I was enjoying, his name is Joe, and a retired inspector from FDNY, also named Joe and myself, also named Joe hit the water at 9:00 a.m. The gulf was like glass and by 10:00 we were anchored up in 20' of water over the May Bridge Reef, approx. 3 miles out of Big Carlos Pass. We had a banner day jigging over the structure with shrimp. Using this method we caught over 4 dozen Spanish Mackerel between us. Joe the fireman had a nice gag grouper. I had the touch catching 2 nice Pompano, 2 16" sheepshead and numerous mackerel.

I also began making longer casts and retrieving with a slow up & down bounce off the bottom. It cost me several rigs, but I was rewarded with my first ever snook, which was released after photo, which my buddy cut off my head and the fishes head, due to the season closed all year due to the kill last year. I also caught 5 17"-18" spotted sea trout. We were bailing fish non-stop from 10:00 to 2:00 and then headed back in to clean the fish.

Ed, I saw on your reply to Bill's hogfish that you were golfing. What are you doing on land with all these fish in the water?

On Monday they tied me up and dragged me to the airport to come back north. I've attached photos

FISHING REPORT by Bill Logan

While fishing the Seven Mile Bridge today I caught a 17.5 inch Hog Fish. These fish are excellent to eat and fun to catch. I was using a light 7 foot rod with a spinning reel 20lb braid to 15lb mono leader and a very small yellow jig baited with a half of shrimp. I thought for sure when I saw how big it was I was going to lose it, but we did manage to net it.

Otherwise it was not a great day for us, we moved twice at the bridge and could not get into the Mangroves; the third move we went to what they call the rock pile; (it's a tripod Hawks Channel marker 49A) which is about 4 miles out and finished up with a 15 inch Mangrove and some Porgies, well you know some days have to be bad. Ha Ha

LESSON 1 by Bill Logan

When wife calls you twice on your cell phone while you are 9 miles out in the Atlantic fishing, to tell you she just saw on the TV that a line of storms are coming across the Florida Keys with heavy rain and strong winds estimated at 60 mph and right over our location, you should listen, (I didn't.) Story goes like this. I had two buddies on board and we were about 6 miles from the Bahia Honda Overseas Highway Bridge and that bridge is about 3 miles from home port. We're in to Yellowtail snappers; limit size is 12 inches, 10 per angler. We had a good chum line going and having fun, a lot of shorts and some keepers thrown in. About 200 yards behind us are 3

other boats, and one other boat on each side Port & Starboard. Like I said before, Arleen calls to tell me about the storms and suggest I start in, I say to her OK Hon will do, I can see the sky is a little dark to the north Hon but we have time. Ten Minutes later I get the second call from Arleen, wants to know if I started in she was a little more to the point "GET IN NOW". I look to the North, the sky is BLACK, I look at the 3 boats behind me and all are pulling up anchors. "OK guys where leaving, Bob you dump the chum and bring in the shrimp. Phil gets on the bow while I bring up the anchor, secure it and get back here right away." I swing the Grady around to 330 degrees which puts me in direct line for the bridge. I have a following sea with 3 to 4 foot waves about 15 feet part, but no rain or wind YET. I put the Grady up on plane doing 4200 to 4500 RPM's that gives me about 25 to 30 MPH and I am flying across the top of the water, with the 3 other boats nearby and hanging on. About 3 miles from the bride the rain starts, so heavy it's like being in a fog, no wind YET, I have my radar and chart plotter on. Two miles from the bridge the wind hit, there is a small island with shallow water around it about 500 yards in front of the old Flagger railroad bridge that you have to be mindful of, and it is in direct line with the bridge opening, we use that part where the trestle has been cut away because going under any other part of the bridge you have to watch for falling debris, then after the Railroad bride about another 300 yards you have the Rte. 1 Overseas Hwy bridge and those pilings are a lot closer, got thru them ok, had to watch for other smaller boats who are under the bridge trying to ride it out, now we are in the Gulf with 3 more miles to go, and it is ugly, the wind is hitting me on the bow portside, plus I had to watch for the lobster and crab pots. I got one, but lucky it did not wrap around the props. After going the 3 miles we have to start looking for the two channel markers that lead you into the channel that takes you to the inlet into the Marina. On either side of those markers it is very shallow, I am very thankful for my radar and chart plotter and the other two sets of eyes I had with me. We made it back to the dock with 3 very nervous and very, very wet fisherman, so wet the stuff in my wallet was wet. I secured the Grady to the dock and we went back to our trailers to wait it out and within an hour and half it was all over went back to the boat cleaned it and the fish for our next fish fry.
