FISHING REPORTS

05/25/2005 by Dick Vesper

Dave Sikorski and I went fishing with Capt. Mel early today and caught lots of bluefish. They hit plugs, poppers and, as seen in the picture, they took the first fly Dave ever tied. Capt. Mel caught a keeper fluke by working a fin-S along the bottom. A clue for you: we caught blues in the bay in water that looked like an oil slick (baitfish oil). Whenever we'd drift a few feet outside the slick, the bite stopped.



06/25-26/2005 by Dave Sikorski

On June 25 and 27 I fished with a friend of mine in the Long Island Sound. We worked the area around an outflow from a small harbor. Using the squid and spearing combination, Craig caught a few Fluke, while I tried both the squid/spearing combo and my soft plastic lures. Our two day total catch was 10 Fluke, 4 Sea Robins, 1 Bluefish and 1 Hickory Shad. If you think we have it bad here in New Jersey, try fishing in New York. Five of the Fluke were over 16 and a half inches but only 2 were keepers. In NY, thanks to an aberration in the MRFSS data, they are only allowed to keep fluke over 17 and a half inches long; and only 3 of them! We had 3 fish that were just short of 17 and a half inches. Overall, it was a very good trip. The next time I go to Long Island, I will definitely be calling my friend Craig...

07/04/2005 by Jeff Barnhart

Since the fluke bite has been kind of slow maybe tuna is the way to go. John Lyszczarz and Capt. Jeff Barnhart show one of several blue fin tuna they trolled up at the Star Fingers on July 4th on Jeff Barnhart's Reel Deal. Fishing with them from the club (somebody

had to take the photo) was Vince Sibona. The tuna were hitting cedar plugs and rainbow spreader bars.

I had a good day today at the Middle Grounds. Caught the last two hours of the incoming and fished the first of the outgoing. I didn't do much, except for a couple of shorts, in my usual spots for the first hour and a half. Then I moved to the southeast, near the sand bar by 108B, and got a steady pick. I ended up with 6 keepers and 14 shorts, mostly on the chartreuse streamer rigs with squid/killie. They were in fairly shallow water, from 4 1/2 to 7 feet. The best bite was from 9:00am to 10:30am. After that, it died off.

07/19/05 by Bill Jann

Ron Nachman, Bill Dabney, and I went out on Ron's boat, the R&R, to the Garden State South reef. We had nice weather (for a change), mostly sunny with a light breeze. We set up with fluke rigs, using mostly squid and killies, and drifted around, looking for some fish in about 75 feet of water. The ocean temp was in the high 70's. Things were slow at first, but we found a "hot spot"

where we had a slow, but steady, pick of fluke and sea bass. No giants, but good eating size fish. We had hoped to anchor up on one of the subway cars, but never really found one, so we drifted over whatever structure we could find. All in all, a nice day. Some of the sea bass were close to 2 pounds. They didn't seem to mind biting on fluke rigs. We were surprised at how few boats were out there, and how little radio talk we heard from fishermen. The fuel prices seem to be affecting everyone.

07/20/05 by Bill Jann

Ron Nachman, Bill Dabney, and I went out to the Garden State South reef yesterday on Ron's boat, the R&R. We had a decent catch of fluke and sea bass.

07/23/2005 Ocean Fishing by Basil Dubrosky

On Saturday, July 23, Dave Sikorski and I went out Little Egg Inlet at 6:30 AM. Waters were 2-3 feet and we made quick time to a 30 foot lump just south of the wreck buoy. We caught 3 quick fluke to 20 inches and then the NE wind came up and made it impossible to hold bottom even with 10 ounces of weight. We tried shallower water and had some nice action with small blues, a nice bonito and a very large dogfish. As we headed into the inlet we spotted a large school of bunker. We proceeded to snag a bucket full of large bunker for crab bait. Fishing live bunker under the school produced no hits. Although we did not hit a lot of fish, we salvaged the day with the action we had on the return trip.

FISHING TIPS FOR TRAVELERS by Basil Dubrosky

While in the Manahawkin area we know we can rely on our friends in the VHFC to help us with the knowledge we need to fish successfully. However, we all travel to new areas for vacations, family visits and business trips. Many of us take our fishing equipment while traveling, hopeful to have some success in the new area. However, we usually have limited time to get up to speed and most of these experiences are not rewarding. The challenge we have in a new area is where to fish and what tactics to use.

The following is a summary of techniques and resources I have used to increase my success in "foreign waters".

Ask Club Members - Many of our members have experience fishing in nearby areas such as North Jersey/Sandy Hook, Island Beach, South Jersey and Delaware Bay. Several members spend the winter months fishing in Florida. Some have spent vacations fishing in exotic areas.

Hit the Internet – Before your trip, use the Internet to get as much information as possible. Check state environmental or fish and game sites, city chamber of commerce site, local newspaper sites and fishing store sites that may lead to local fishing reports. Call a tackle shop to get more specific information. These initial steps will help you to decide what to bring.

Visit a Fishing Tackle Shop – Once you arrive at the destination visit a tackle shop and talk with the staff and customers. Pay special attention to differences in terminal tackle and bait. Ask for directions to walk in fishing areas. Ask about piers and areas where fishermen congregate. Get a local tide chart and papers similar to our Sand Paper. Get information on local guides and buy a fishing license if required.

Walk and Talk – Go to the obvious places that you will find fishermen at different times of the day and ask them

about their success. Pay special attention to terminal tackle and bait used. Beaches, boat rental establishments, gas docks/marinas and party boat docks can yield good information. I once got my best information while chatting with a road crew foreman who told me how to get walk in access to a great fishing spot.

Hire a Guide – I know this sounds a bit extravagant but you can learn more on a trip with a guide than any other way. If you are staying for several days you can use the information and techniques learned from the guide on the first day to fuel excursions on your own for the next few days.

In summary, make your next fishing experience while traveling more rewarding by doing some advance research. When you get there, hit a tackle shop, talk to the locals, get a guide, have fun and give us all some feedback when you return.

VESSEL SAFETY CHECK by Ed Wetmore

A Vessel Safety Check VSC) is generally performed on recreational boats under 65 feet. VSC requirements parallel federal and individual state regulations regarding equipment and safety conditions

of the vessel. VSC is not a law enforcement action. No official report is made to any law enforcement agency.

A vessel safety check is only performed with the owners consent and he/she must be present at the time of the VSC. The owner of the vessel will be presented a "Vessel Safety Check" decal depicting not only a successful completion of the safety check but a demonstration to the rest of the boating world that the owner is operating a safe vessel.

(See our May 2005 Newsletter for more details.)

This check will last about 10-15 minutes and I will do all the paper work (very little) and present the captain/owner with a complete copy of the VSC. I will describe that boats under 26 feet have less requirements than the larger ones.

To arrange a VSC for your boat during the first three weeks of July, please call me at 609-294-6956 (home) to schedule a date. I will come to your location and inspect their boat.

LOTS MORE NON-REFRIGERATED BAITS THAT WORK by Dick Vesper

Most of us have grown accustomed to using plastic baitfish to jig for our favorite inshore species. Now there are more new baits in town and I'm hearing a lot of good reports from local catchers of fish. For example, in Capt Mel's (Fisherqueen) report of Sunday, July 24, 2005, she writes "I had the gang from the fishermen magazine Jim Hutchinson with gal Michelle and John Debona out this weekend for some fluking and just for a plain good old time. We started off in Double Creek and picked some fluke in the 2 lb range. Then we headed over to the sod banks to throw some plastics and picked up some bluefish along with another fluke. These guys were using the new Berkeley Gulp Sheet Bait. You cut it with scissors and it looks like fish skin or shall I say in a low voice fluke belly??!!! This stuff really works. We caught all but one of the fluke on it. Try it out. I'm going to get

Summarizing what I've picked up so far:

1. New products, such as the Berkley Gulp Saltwater series are rapidly replacing live, fresh or frozen

- bait in some local tackle boxes. As you can see in Capt' Mel's Report, Jim Hutchinson seemed to be very successful in using the sheet bait in place of squid strips or fluke bellies to catch fluke
- Several fishermen and two tackle shops reported good success on the beach catching Kingfish with synthetic worms; either Fisherman's Choice Squid Worms or Berkley Gulp Saltwater 6" Sandworms.
- 3. These products catch fish, need no refrigeration and are cheaper than "spoilable" worms.
- 4. I'm especially enamored with the "Gulp" products (fresh and salt water). They give off a scent that seems to work in our fishery.
- 5. Two cautions: Don't put used baits back in with the new. Don't expose/store in a lot of sun light. Fortunately, they come in resealable zip lock bags to keep them "fresh".

[Ed. Note: The next thing some company will try to sell us will be a little black box for our boats, cars or for our pockets that will show us where we are on a digital chart and helps us to retrace our steps back home, even in the dark. Really? Naaaaaah!]
