FISHING THE CIGARS WITH GREAT RESULTS

This past week had brought very positive reports of super blue fin tuna fishing inshore. So, Larry Gonnello and Barry Gabler decided to put a trip together for Friday, on the Crusader, to bring home some sushi grade tuna. We planned our trip the day before, to follow the advice of those who had gone before us and to travel to the area of the Cigar.

The Cigar is an elongated lump that lies about 180 degrees for 30 nautical miles from the Little Egg Inlet. Its boundaries are in depths of up to 140 feet and the lump itself rises up to 110 feet. Blue fin tuna were taken all week on ballyhoo rigged behind island girls or a sea gypsy. The fish were supposedly taken way back and deep.

The twin hulls of the Crusader pushed back off the dock prior to day break to get to the Cigar as early as possible. Weather was perfect with light S E winds and unlimited visibility. It is tricky and one must navigate slowly with the aid of a spotlight to get through the false channel to Long Point without becoming fouled on a crab pot. Once in the ICW, with the aid of its GPS plotter and Radar, the Glacier Bay Catamaran, Crusader, cruises at a comfortable 26 knots.

An hour after breaking the inlet we were in position to troll up on the Cigar. We decided to put out only 5 lines - 2 very deep on planers, 1 very, very, long and deep with a 10 ounce trolling weight, 1 even longer behind a bird, and one long behind a bird. We set our trolling

speed at 4.5 knots. It was quite a while before our first runoff and unfortunately we got covered up with huge bluefish that were no match for our 30 pound class tackle. All rigs and hooks had to be checked and re-rigged after the attack of the alligator blues. Trolling again, we took a very subtle hit on a deep down rigger and were rewarded with an 8 pound mahi that was quickly gaffed, subdued and stored on ice in the Crusader's ample fish boxes. Finally, we were rewarded with a "quality" runoff that dumped about 100 yards of line before Barry had a chance to pick up the rod. A good hook up and the fight was on, only to terminate early due to equipment failure as the store bought ballyhoo rig broke. Failure and fishing go hand and hand, both begin with "F", and the expletive that we yelled as the fish gained freedom also begins with "F".

Trolling again, the line started screaming off the real long line with the trolling weight. This time it was Larry's turn at being the hero or the goat. I cleared the other lines and maneuvered the boat as Larry fought the fish. It took some time to get the fish to boat side as we had over 2 hundred yards of line out. Every time it saw the boat it ran and sounded. Finally, I saw some color, put on the gloves, and got ready to leader and gaff the fish. The quote of the trip came now, as Larry had wound up tight to the rod tip. I grabbed the leader and went to pull the fish in for the shot and with much dismay said. "Larry, I am going to need a much bigger gaff"!

I quickly ran into the cabin and readied the large gaff. The fish was big and still a little green. I could not leader and gaff the fish myself. We set the rod in the far rod holder, put the clicker on and pulled off most of the drag. I lead the fish boat side for Larry's best gaff shot. He stuck the steel home and brought the tuna over the side and into the fish bow. The fish was over 49 inches and weight was estimated at over 70 pounds. We bled the fish and stuffed its body cavity with ice to get the core temperature down as quickly as possible and covered it with ice.

The ride home was beautiful and our thoughts were of grilled tuna for dinner.

These fish are here now - so if your equipment and your body are up for the test, and Mother Nature cooperates, go for it! The big boys travel over many miles of very productive fishing grounds to go to the canyon to get tuna. This is the second time in the past few weeks that we have had decent mahi and blue fin tuna within 35 miles of the inlet.

Yesterday is gone, tomorrow is not here yet, live for today!

BOAT US BOAT DISCHARGE UPDATE by Ed Wetmore

For 34 years the federal Environmental Protection Agency (EPA) has exempted discharges from recreational boats from the Clean Water Act permit system. Regrettably, a recent court ruling cancelled this permit exemption. EPA is required by the court decision to develop and implement by September 30, 2008 a national permit system for ALL vessels in the United States for a variety of normal operational discharges.

We have been working behind the scenes with other boating organizations to get the exemption reinstated for recreational boats. Fortunately, the Recreational Boating Act of 2007 (H.R. 2550) has been introduced by Representatives Gene Taylor (D-Miss) and Candice

Miller (R-Mich) which would protect recreational boats from being swept into this unnecessary and expensive permitting system. It is critically important that H.R. 2550 be passed and your support is essential. Please contact your Congressman and Senators TODAY and ask that they co-sponsor or support H.R. 2550.

If the permit system becomes a reality, you will be required to pay for a state permit for each of your boats. EPA will be monitoring your deck runoff, grey water, bilge water, engine cooling water, and the use of copper bottom paints.

The original lawsuit that led to this court decision sought to address ballast water discharges from large ocean-going ships, which can introduce damaging aquatic invasive species into U.S. waters. Keeping our waterways clean and preventing the spread of invasive species is of utmost importance to the future of boating. But taking a complex permitting system designed for industrial dischargers and applying it to recreational boats will not yield significant environmental benefits and it will come at a very high cost. Requiring recreational boaters to purchase a permit would not prevent the spread of invasive species.

BoatUS has been a leader in educating boaters about Clean Boating practices for more than a decade. Our nonprofit Foundation has funded local education projects on invasive species prevention, helped develop voluntary Clean Marina programs, and authored much of the country's Clean Boating outreach. These positive education efforts are making a difference.

Please ask your elected federal representatives to support H.R. 2550. It is common-sense legislation. As you send your emails to your Members of Congress, please copy BoatUS at GovtAffairs@BoatUS.com. We'd also like to ask you to send a copy of your correspondence to the EPA, so they can see how this will affect citizens. However, please know that if you choose to send it to EPA, it will become a part of the public record. EPA's email is ow-docket@epa.gov, and your email needs to have a subject line with Docket ID No. OW-2007-0483.
