The rules are simple: one of our membership has to catch a fish of one the above species and get it weighed and recorded on our official weigh-in forms at an official weigh station. Our two official weigh stations are: Fishermans Headquarters (Ship Bottom) and American Sportsman Bait & Tackle (Manahawkin).

If you have weighed in the largest fish of a particular species for the calendar year 2005, then, early in 2006 you will receive the FOY trophy for that species.

FISH OF THE MONTH AWARD by George Fruh

The March-April Fish of the Month is Winter Flounder. Congratulations to Jerry Papp for his 2 lb 4 0z Winter Flounder; caught on April 25, 2005. Jerry will receive his prize at our May meeting.

Weakfish is the Fish of the Month (FOM) for May. The FOM weigh-in rules are the same as for FOY.

STRIPED BASS RULES by Dave Sikorski

The Striped Bass rules are the same as they were in late 2004. We still have our 24 to 28 inch "slot fish", but we are not allowed to keep any Striper between 28 and 34 inches. Make sure you know the current regulations when you go fishing for striped bass.

Also, the NJ Division of Fish and Wildlife has revised the Striped Bass Bonus Program for 2005. Applications must be received by May 31, 2005 and the program will begin on September 1, 2005.

NJ DEP COMMISSIONER BRADLEY

CAMPBELL'S REPLY by John Borick

In the January 6, issue of The Fishermen Jim Hutchenson Jr., wrote an article called New Jersey Closed to Hunting and Fishing, in which he included a petition to remove Commissioner Bradley Campbell from office. Because of the huge response from the outdoorsmen and women of New Jersey, Commissioner Campbell , who heads the Department of Environment Protection (DEP) called the staff of the Fishermen into his office. In the February 17 Issue of The Fishermen, the DEP Commissioner addressed the complaints against him. This is a summary of the article.

Campbell said he supports the activities of hunters and fishermen and is against attempts to put animal rights activists on the Council.

In regard to his lack of support for the 2004 bear hunt, the Commissioner perhaps admitted that his decision may have been political, but asked outdoors men to look towards the future.

On the freedom to fish bill, he states, that "the bill sets a scientific standard that can never be met." Marine fisheries are subject to many stresses, ranging from recreational fishing to storm water runoff and lack of forage species. He is working with the Recreational Fishing Alliance (RFA) to narrow the gap.

He is in support of the artificial reef program by his recent allocation of a first ever \$100,000 budget item towards the program, but he never said no to Marine Protected Areas. His goal is to get the subway cars resolved.

On the Striped Bass Bonus Program Campbell stressed that some state biologists may argue that utilizing

\$300,000 for continuing the bonus program could be better used elsewhere.

"It's time to heal the rifts that have come about," Campbell added.

Related comments by John Borick: In a recent and related note, the JCAA Jersey Coast Anglers Association might take it upon themselves to run a lottery program for the Striped Bass Bonus Program, and assist the Fish and Game with the costs.

Commissioner Bradley Campbell should be credited for standing there and taking the questions. He strongly supports the work of the Fish and Game Division. Being as how this meeting came about because of the response from you, the outdoors men and women of New Jersey, you'll ultimately have the final say. Only time and another New Jersey election cycle, will tell.

FISHING REPORT by Don Longstreet

Jerry Papp and I went to Atlantic Highlands to do some fishing on a party boat named Teal (732-872-0744) as our area has been very slow. Well, Jerry and I caught 30 flounder Jerry won the boat pool as well. Also that day 7 keeper stripers were caught; 3 on flounder rigs. In case anyone is interested, the price was 37.00 for the day including the pool.

FISHING REPORT

On April 30 Basil Dubrosky caught a 26 inch Bass in the surf at Ship Bottom on fresh clams. He also caught 3 shorts over the same weekend. He is now in the lead for the biggest Bass of the year.

SHARK FISHING, A REAL THRILL by Basil Dubrosky

We are very lucky here in New Jersey to have a great shark fishery just off our coast in June. I have been out several times over the past 15 years on what have been some of my most memorable fishing trips. Usually you have to run off shore at least 25 miles to hit the migration of the bigger fish.

Shark fishing is a lot like bobber fishing for snappers in the lagoon. You take a rod, a sharp hook with fresh bait, decide how deep to set your bobber, sit and wait and hope the hook sets when you strike. With shark fishing you just use bigger stuff. A 6/0 outfit with a stand up rod, heavy specialized wire terminal tackle and whole mackerel. You set your party balloon bobbers at various depths and sit and wait and hope that when you strike you are strong enough to hold on.

The idea is to drift with a chum bucket over the side, chunking bait as you go. It takes about an hour of drifting before things start to happen, but when you spot a shark, or one of the bobbers starts dancing, it is the thrill of a lifetime. A minimum of three strong and experienced fishermen are required for a shark trip. One on the pole, another on the tag stick and one on the line. The pole fisherman should have a rod harness or a rod rest, the line man should be wearing leather gloves and have some strong wire cutters and the tag man should have a good aim to place the tag. They should be the type of fishermen that don't get nervous coming eye to eye with a large blue shark (are you kidding!).

I tagged a blue shark several years ago off the 28 mile wreck in June that was recaptured off Montauk that same summer. The National Marine Fisheries sent me a special hat to commemorate the event.

Often you run into large schools of bluefish and, although an unwanted nuisance for shark fishing, they can provide some great downside action. I once had bluefish swarming around the chum bucket so thick it looked like you could walk on them.

Shark fishing is the ultimate macho experience. It pits you against one of nature's largest predators and is full of rewarding crew teamwork and high fives.

If you meet the qualifications and would like to share expenses and go shark fishing this June, please contact me. I would also consider sharking on your boat if you would prefer.

FISHING STORY by Roland M Dixon

Saturday, April 23, I managed three rainbow trout and one brook trout from the upper reaches of the Passaic River. All are from the NJ State stocking program. I was surprised by the first one and even more so as the day wore on. All succumbed to a fly rod with a Garden-Hackle.

Only other item was a trip April 10th for blackfish. About 25 people on the "Searcher" out of Barnegat Light (\$40.00/person with green crabs). Total catch was about 15 fish. I managed one about an inch over the minimum size plus one bergall.

THE FIRST VHFC TOURNAMENT by Basil Dubrosky

The first VHFC fishing tournament was held on Saturday, August 26, 1989 for all members. It was a multi-species tournament with first place only prizes. The winning Weakfish was 2 and 7/8 pounds. I remember this fact because my Weakfish was 2 and ³/₄ pounds when I weighed it in at the official weigh station, American Sportsman in Manahawkin. I left the weigh station thinking I was the winner only to lose when I reviewed the final statistics.

Nowadays, this size Weakfish caught by a member is commonplace. We have come a long way with the size and number of fish that are caught in tournaments and the number of club members that are quite proficient and competitive at fishing. I think we can attribute this success to the open exchange of information and techniques at our monthly meetings and our guest speakers who have taught us much over the years.

The last Saturday in August became a traditional multi-species tournament date for the club marking the end of the vacation season. Once again this year the VHFC will have a multi-species tournament on the last Saturday of August (Fluke and Sea Bass) but the number and size of the fish caught will be much larger than in 1989 due to the successful programs of the VHFC over the years. (Ed. Note: Basil was part of the beginnings of our club. He has membership #2.)

VESSEL SAFETY CHECK by Ed Wetmore

Vessel safety checks (VSC's) are generally performed on recreational boats under 65 feet. Vessel safety check requirements parallel federal and state regulations regarding equipment and safety conditions of the vessel. VSC is not a law enforcement action. No official report is made to any law enforcement agency.

A vessel safety check is only performed with the owners consent and he/she must be present at the time of the VSC. The owner of the vessel will be presented a "Vessel Safety Check" decal depicting not only a successful completion of the safety check but a demonstration to the rest of the boating world that the owner is operating a safe vessel.

A Vessel Safety Check (VSC) is as follows:

• A voluntary check of vessel compliances with all federal and state laws

• An authorized boating safety activity contributing to the Coast Guard/ US Power Squadron recreational boating safety mission

• Opportunity for the exchange of safety information

The following requirements will be checked on all recreational boats less than 65 feet: Display of vessel's numbers; Registration of the boat; Personal Flotation Devices (PFI); Visual Distress Signals; flares; Fire Extinguisher for boats over 26 ft.; Ventilation; Backfire flame control (inboards); Navigation Lights; Marine Sanitation Devices (if aboard); Navigation Rules; Overall Vessel condition.

Items that will not be inspected but encouraged to talk about include marine radio, anchor and anchor line, first aid kits, safe boating class, float plan & Insurance.

The VSC will last about 15-20 minutes and I will do all the paper work and present the captain/owner with a complete copy of the VSC. I will describe that boats under 26 feet have less requirements than the larger ones.
