# PRESIDENT'S MESSAGE

August 1, 2014

Hi everyone, 10/7/2014

I attended the Atlantic States Marine Fisheries Commission Striper Public Comment Meeting held in Toms River and voiced the decision voted on at the last VHFC meeting. I expressed the following:

 <u>Coastal Recreational Fishery</u> – Option
 B1 - A 31% reduction in fishery mortality in 1 year @ 1 fish 28" minimum and the same for Chesapeake Bay – **Option B10** 

- <u>Commercial Fishery Management</u> –
  **Option B16** A 25% reduction from
  2013 quota and for the Chesapeake
  Bay **Option B17** 2013 quotas were
  13% lower than 2012 harvest, resulting
  in a 32% reduction.
- 3) <u>Commercial Quota Transfers</u> Option
  A No transfer of commercial quotas
- 4) <u>Commercial Size Limits</u> Option A Status quo

This whole process will result in a change to the NJ and all other Atlantic coastal states striper regulations for 2015 and probably a year or so beyond.

Thanks to a generous donor, the November meeting auction is back on the agenda. In the newsletter, you'll find a current list of the items presently available for auction. This year we will assign a reasonable starting

The following is taken from the NJDEP Division of Fish and Wildlife (Division) and Barnegat Fishing Hole Web-sites. While the hearings have passed. Take the time to review the Draft Addendum that was mentioned in President Message.

August 20, 2014

The NJDEP Division of Fish and Wildlife (Division) has scheduled three hearings to gather public comment on Atlantic States Marine Fisheries Commission's (ASMFC) Draft Addendum IV to Amendment 6 to the Interstate Fishery Management Plan for Atlantic Striped Bass. The Division strongly encourages the public to attend these meetings in order to assist managers in the management of this precious resource. In addition, the Division urges striped bass anglers who fish the Delaware River, and are unable to make any of the New Jersey hearings, to attend the hearing hosted by the Pennsylvania Fish and Boat Commission. The information for the New Jersey and Pennsylvania hearings is listed below.

The Draft Addendum proposes new fishing mortality (F) reference points, as recommended by the 2013 benchmark stock assessment, and associated management measures to reduce F to a level at or below the proposed target within one or three years. It responds to results of the 2013 Atlantic striped bass benchmark assessment indicating F in 2012 was above the proposed F target, and female spawning stock biomass (SSB) has been steadily declining below the target since 2006. This means even though the stock is not overfished and overfishing is not occurring, SSB is approaching its overfished threshold and stock projections show SSB will likely fall below the threshold in the coming years. In addition, a similar decline has been observed in total harvest. In response to these factors, the Draft Addendum proposes management options to reduce fishing mortality to the target level.

The Draft Addendum includes a suite of management options to reduce recreational and commercial harvest along the coast and in the Chesapeake Bay under three reduction timeframes. The timeframes include (1) reducing F to its target in one year with a 25% reduction in 2013 harvest in 2015 (2) reducing F to its target within three years with a 17% reduction in 2013 harvest in 2015, and (3) reducing F to its target within three years with a 7% sequential reduction in harvest for three consecutive years starting in 2015. Specific options to be considered include bag, size, slot and trophy size limits for the recreational fishery and quota reductions for the commercial fishery.

Given the Albemarle Sound/Roanoke River (A/R) stock of striped bass contributes minimally to the coastwide complex when compared to the Chesapeake Bay, Delaware, and Hudson stocks, Draft Addendum IV proposes it be managed by the State of North Carolina using stock-specific biological reference points. These stock-specific reference points, which have been approved by the Board, would result in a separate quota that is set to maintain F for the A/R stock at its target level. The Board tasked the Technical Committee with the continued development of Chesapeake Bayspecific reference points for future use.

Anglers and other interested groups are encouraged to provide input on the Draft Addendum either by attending state public hearings or providing written comment.

# **Swordfish Report**

I ride my bike just about every day down Mill Creek Road in Manahawkin. This past Saturday as I road past Bill Figley's house, I noticed Bill lugging a very big fish in his driveway. I did a double take, circled around and went into his driveway. There was Bill with an 8 foot swordfish. Fortunately I had my camera with me and I got a nice photo. Then Bill explained everything to me. It was the last day of fluke season, and with heavy seas, he was not able to get out. So Bill decided to winter flounder fish in Mill Creek off of his dock behind his house. He rigged a light fishing rod with a Hula Popper and began to fish for winter flounder. Soon Bill had a hookup. He knew that he had a very big fish on because line started really pealing off of the reel. After fighting the fish for a couple of hours, Bill was able to bill the large 8 foot swordfish and wrestle it up onto his dock. Just by coincidence I saw Bill as he was carrying it around to his driveway.

Now, all kidding aside and on a more serious note: Bill Figley carves many types and sizes of fish from different types of wood. He really gets into the detail part of it, scales, fins, eyes, teeth and colors. One time Bill showed me a fish with teeth that he made from rose bush thorns, really very impressive.
