PRESIDENT'S MESSAGE

Hello everyone,

Can someone tell me why, when we get sustained winds from the South the ocean water temperatures go down and air temperature go up. Pretty sure I know about the air temps., but what is it with the water temps.? Four or five days of strong southerly winds took 5 to 6+ degrees out of our inshore water and sent the bunker and stripers scrambling for warmer environs. Just ask any of the 15 fishermen that were on the VHFC **Striper** Outing. We caught bass, but they were definitely not stripers!

I just hope those southerly winds, that still blow as I write this, will move me and my gear more swiftly and efficiently as I head North to New Brunswick, Canada for my 46th week/year of small mouth bass fishing on the Spednic Lake

chain of lakes. Having fished small mouth for 45+ years and loving every split second of it, I must confess that stripers have captured my heart. I love that fish, the look of that fish, the massive head shakes of that fish, the impulsive attack of that fish at the mere sight of a distressed bait or plug, the strong heart of that fish....I'm forever hooked!!! First, the **Jersey Coast Anglers Association Fluke Tournament** to be held one day, August 24, 2013. This tournament offers \$1000.00's in prizes for each of ten(10) weigh station ports where you are competing only against other boats using that port. This is truly a New Jersey State tournament with ports from Sandy Hook to Fortescue and the proceeds go to the one organization, the JCAA, that fights for the rights of New Jersey recreational fishing community every single day of the year. The Gala Award Ceremony is to be held at the Golden Nugget in Atlantic City on the evening of September 6th and, I am told, is worth the entry fee alone. Quite an evening!!! THE LEGISLATIVE REPORT**Summer Flounder Add-On by Tom Fote - JCAA**

As I reported, the Atlantic States Marine Fisheries Commission voted on a conference call to allow New Jersey to add days to the end of the summer flounder season. I voted for this because I thought it would help the heavily impacted recreational fishing industry. I also realize that the way these days are added it does not affect our original quota except to add on to the quota. I read some interesting comments in the newspaper and I think some people have a difficult time grasping how this addition is implemented. The easiest way to understand is to look at this addition of days as though it is a commercial transfer of quota from one state to another. When we transfer commercial quota it is because one state has an underused quota and allows another state to harvest that quota. It is separate poundage of fish that is transferred and has no impact on the existing quota. If that commercial fishery goes over its existing quota, it is not because of the added days but because it exceeded both the

original and the additional quota. In order to do the transfer of recreational quota, ASMFC and NJ had to tabulate how many pounds of fish would be needed for each of the added days. ASMFC and New Jersey calculated that we could add a specific number of days based on the poundage available in relation to the historical catch figures. That means that in order to exceed quota, we would have to exceed the original quota and the additional quota both. Remember, those quota and catch figures are based on a normal year. Given the impact of Sandy with boats destroyed or damaged and marinas not yet in operation, there seems little possibility that this will approach a "normal" year. I know this is a stretch, but recognize that common sense would suggest that this year we will have less participation, fewer boats in the water and fewer trips than in previous years. I need to add a qualified since we are dealing with the National Marine Fisheries Service and their fatally flawed data collection system. I still continue to give good odds that we will not exceed our summer flounder quota this year. I could be surprised but I can't believe even this system is sufficiently flawed to measure us at above quota or increasing trips. In my judgment, we should avail ourselves of the additional days.

The other reason I am supporting this addition of days is because it has the greatest impact on those who fish from the beach. When we raise the size limit, the beach anglers have very little access to legal size summer flounder except in September, October and November. We have lost October and November but adding a few days in September will give them an opportunity to catch a few summer flounder. For the boat fishermen, these additional days will give them something to fish for until the black sea bass season opens again. It's a win-win!

Sand Dredging is Next, Biggest Step for Bay Cleanup

STAFFORD — State workers and contractors cleaning up storm debris in Barnegat Bay are entering "what could be the biggest chunk of the

project” as they move toward clearing new shoals and sandbars left by superstorm Sandy, a top state environmental official said Tuesday.

The goal now is to have most of that dredging done by June and completed by mid-August, said Jane Kozinski, an assistant commissioner with the state Department of Environmental Protection, who spoke to the Long Beach Island-Southern Ocean County Chamber of Commerce.

The DEP and Federal Emergency Management Agency are haggling over which dredging sites will be eligible for federal disaster aid to pick up the costs, Kozinski said.

FEMA guidelines define when debris pickups qualify for federal reimbursement — specifically, wreckage caused by Sandy that poses a continuing risk to public safety or to property, or can impede the region’s economic recovery from the storm, she said.

So DEP workers have to show that targeted areas were filled with sand propelled by the massive Oct. 29 storm surge. The state has some updated pre-storm charting thanks to the Barnegat Bay restoration project, which engaged a team from the U.S. Geological Survey to chart the bay last year.

But the history of other shoals along the coast may be harder to document.

“There are some areas that are obvious, like the big shoal behind Lavallette,” Kozinski said. “Some of the shoals in front of the mainland creeks are obvious, too.”

Use your head. If you’re going through an unfamiliar area, slow down. Boaters who spot debris should call the DEP at 1-877-WARN-DEP, provide the best location they can — Global Positioning System coordinates will lead contractors to the exact spot.

Waterfront property owners who still have damaged docks or other property in the water should “make sure it’s tied down,” because contractors have been moving through lagoons and other areas on a tight schedule, and will

remove anything that looks like unclaimed wreckage, Kozinski said.

Northern Barnegat Bay has had the biggest lode of debris, with some 17,000 cubic yards removed by contractor CrowderGulf so far — including about 30 boats, three cars and three houses near Mantoloking, Kozinski said.

From central Barnegat Bay into Delaware Bay, contractor AshBritt and its New Jersey partner Conti Construction have recovered between 8,000 and 9,000 cubic yards, and are working on four houses in Delaware Bay this week, she said.

Some dredging projects are being delayed by the spring arrival of endangered bird species, like the red knot and piping plover, that feed or nest on beaches, Kozinski said.

But the aim is to have all the storm sediment moved by mid-August..

“Everyone should feel positive about this summer season,” she said. “It will be different. But we’ll be OK.”

VHFC OUTING

This trip was scheduled for November 2012, but we all know who paid us a visit that changed everything. The deposit was held over for this year and a Striper Outing was planned for May 24, 2013 aboard the Searcher II out of Barnegat Light.



After a few cancellations, a few additions and countless days of concern about the forecasted weather and seas, 15 VHFC members and family met and went fishing. The captain's plan was to fish for blue fish on our way out of the inlet and then head North up to the "bathing beach" area of Island Beach State Park to snag & drop and live line bunker for stripers. As it turns out, the diamond jigs we started out fishing for blues with became the lure we had on all day. There were no blue fish as we left the inlet so we headed North. Now those angry seas we were all concerned about turned out to be smooth swells, no chop at all, no winds, no thunderstorms. Apparently the forecast scared off loads of other fishermen as we saw virtually no other boats all day.

We stopped on a couple of bunker pods the captain had marked, but none of us saw any evidence that they were around...nothing on the surface at all. We moved from one spot to another, fished in tight to the beach, away from



the beach and as far North as Seaside Park - NOTHING! This jigging was getting a bit boring allowing Jeff Barnhart to develop and perfect an "over the shoulder" jigging technique that paid off a bit later. The captain headed out into deeper water and we ended up drifting around a number of, what we assumed were, lobster pot buoys. Still jigging with the diamond jigs, we hear "FISH ON". Joe Marone caught a nice black fish, had to go about 5-6lbs! Who knew you can catch tog on a diamond jig!?



The action started to pick up as many of us started hooking up on black sea bass. Keepers and shorts came over the side and the "over the shoulder" jigging technique paid off as Jeff caught the largest sea bass of the day with Fred Bauer's a close second and Bill Dabney also pulling in a contender. Someone caught a decent sized spinney dogfish which was cut up for bait that we never got to use. It was around 1:15 and we started back for the inlet and stopped to work some bird action at the inlet. One of our guys

hooked up on a little 2-3lb blue before we headed for the dock.



Even though the wind kicked up late in the trip and we had a few periods of rain, the weather was more than tolerable. The ocean water temperature had dropped 5 degrees since I was out last Friday when bunker was everywhere. The trip was not what we were all expecting, but the captain spared no fuel or effort trying to put us on stripers or fish generally. As for me, I was really looking forward to my first striper of the year. That didn't happen, but I had a hell of a good time trying to catch one with 14 other guys trying as well. I don't know about the rest of our group, but I sure didn't have anything else to do today that would have been more fun.

FISHING REPORTS

Fluke Fishing Report for May 17 by Vince Sibona

Jeff Barnhart and I left the dock at 6:45 am on the SEA BONA and headed out of Barnegat Inlet. We went just past and South of the Bi Buoy knowing that our drift would be North and we would going passed the mouth of Barnegat Inlet. Our lines were in the water about 8:00 am. The wind was light so we had a slow drift. The water temperature was cold, mid 50's. It was a cool, cloudy day with mist at times. On our first drift, we caught 2 dogfish sharks, 3 skates and then I hooked an 18 1/2 inch fluke. On the next drift, we caught nothing. So, at about 11:00, we decided to go to the Barnegat Reef. There were 6 boats on the reef. We kept an eye on the boats to see if anyone was catching anything. We made 2 drifts in 2 hours. We didn't catch anything on Barnegat Reef and we didn't see anyone on the other boats catch anything. At 1:00 pm we headed home.



April 25, 2013

Didn't feel like sitting around on a warm night. So I headed out to the unani creek. In an hou and a half caught 18 trout. Kept four, including a big brown. All but two rainbow caught on my old faithfull kastmaster lure.

Joe Filice reported that he fished the low tide the afternoon of Memorial day Weekend because that's when I could. I was able to

determine where a cut was and put a bunker head in the center of the cut. I was rewarded with a 32" dinner fish. I also know of a 4lb. Weakie caught on a gulp fluke rig as well as numerous fluke being caught in the surf, unfortunately not by me. I will be hitting the surf all this week looking for the big one.

Well, as I said in my last report, I tried all week, in between scraping and painting, for a bigger Stripers. The south wind was howling all week and put the fish down, I can't remember catching during these heavy south blows and this week was no exception, I caught nothing.

On Sunday, June 2nd, my wife and I took two of our granddaughters to the beach in the morning. It was low tide and the wind was again howling out of the south. I noticed a deep trough just to the right of where we came on. In the afternoon, I took the girls back up by myself, no wife backup. While they played, I watched them and also was throwing a fluke rig with White Gulp 4" mullets on a jig and a teaser. On the 3rd cast I brought in a nice 20" Flattie. A few more casts and then the girls were getting too brave with a very rough incoming tide, so

the rod went in a spike and I was on guard duty. But I got a nice dinner fish
