If you have weighed in the largest fish of a particular species for the calendar year 2013 then you win the FOY trophy for that species. **Note:** your dues have to be paid before you catch an eligible fish.

Striped Bass**

Striped Bass

The results of 2013 striped bass assessment and peer review have been published on the Northeast Fisheries Science Center's web site. The publication includes the SAW/SARC Striped Bass Assessment Summary report and the peer review reports from each panel member. The publication does not include the full assessment report which will be made available in 2-3 weeks

The ASMFC Striped Bass Board will receive an overview of the 2013 assessment and peer review at the October Commission Annual Meeting. Please recall the assessment was completed using preliminary 2012 landings data (final landings data were not available at the time of the assessment workshop). The Technical Committee will be updating the assessment with the final 2012 landings data prior to the Board Meeting and will present the assessment results with the final 2012 landings data, therefore the information presented at the Board Meeting will have slightly different final numbers than the SAW/SARC report.

When I went to the link for the review I read the summary and it stated:

State of the Stock: In 2012, the Atlantic striped bass stock was not overfished or experiencing overfishing relative to the new reference points from the 2013 SAW/SARC57 (Figure B1-B3). Female spawning stock biomass (SSB) was estimated at 61.5 thousand mt (136 million lbs), above the SSB threshold of 57,904 mt, but below the SSB target of 72,380 mt. Total fishing mortality was estimated at 0.188, below the F threshold of 0.213 but above the F target of 0.175.

When compared to the biological reference points currently used in management (ASMFC 2008), the stock is neither overfished nor experiencing overfishing. Female SSB in 2012 is above both the target (46,101 mt) and the threshold (36,000 mt), and F2012 is below both the target (0.30) and the threshold (0.34).

Fall is now upon us and Winter will arrive more quickly that we would like. Stripers will be the hot ticket to catch. Least we forget as the fall fishing season comes so does the cooler days and nights. When it comes to winterizing our vessels we sometimes wait to the last minute when it may be too late. Go to the Boat/US website and find the checklist to do it properly and have the correct materials.

As many of know I also perform the Vessel Safety Checks for USCG Auxiliary. While the season is coming to the end, Think about having one done next year. This is a no cost service and assists each boater to have the minimum safety equipment on board.

If successfully qualifying, a decal gets place on your vessel. If you do not qualify, no fear, I does not get reported and we will discuss the items and I will come back and do it all again. The advantages to displaying a decal are that should you get stopped and boarded by the Coast Guard it allows them know that you take safety seriously and you may also get a discount on your boat insurance. MASS ANGLERS TO BE BANISHED FROM CLOSED AREA?
RFA Calls For Action on Behalf of New England
Saltwater Anglers

September 19, 2013 - The Recreational Fishing Alliance (RFA) is urging U.S. saltwater anglers to help protect access rights for New England's cod and haddock anglers and the local recreational fishing businesses who depend on those fishermen.

An RFA fax campaign is now underway to urge

the New England Fishery Management Council (NEFMC) to oppose any changes to the Western Gulf of Maine closed area which would completely restrict angler access.

NEFMC is considering taking habitat protection measures which will result in new closed areas for charter/party and recreational anglers as the Stellwagen Bank National Marine Sanctuary wishes to conduct a research effort in a 55-square-mile "reference area" off the New England coast. The letter to NEFMC which RFA urges all anglers to support says that if the reference area is put into place, anglers will be forced to travel up to 40 nautical miles from shore to find a few cod and haddock for the table, a proposal which will have a devastating impact on our recreational fishing community.

At the RFA homepage, be sure to check on the *Sept/Oct 2013* newsletter on the top-right side of the page, and an article on page 21 from Capt. Barry Gibson regarding this proposed Sanctuary Ecological Research Area, or SERA II.

FISHING REPORTS

This report is from John Toth of the JCAA covering a presentation at a recent New Jersey Outdoor Alliance meeting.

Chris Wojik and John Tiederman from Monmouth University who are involved in a campaign (Stripers for the Future) to educate anglers on best releasing practices to increase the survival of released striped bass. We recreational anglers have been enjoying catching record numbers of striped bass, but the stocks of this fish can be reduced by poor handling methods and recreational anglers should do everything we can to maintain healthy levels of this stock. For example, the **Do's** and the **Don'ts** for handling bass:

Do

- Release the fish without taking it out of the water
- Handle the fish with wet hands or gloves
- Cradle the fish with one hand under the belly and one under the shoulder

- Resuscitate the bass by pulling it forward or in a figure eight (8) through the water by the lower lip. Never move it backwards.
- Get the fish back into the water quickly! Try to limit exposure to 15 seconds.
- Use barbless hooks for quick release
- Use circle hooks when bait fishing
- Leave deep hooks in the fish by cutting the leader off close to the hook

Don't

- Lift bass by the mouth or tail. This can cause serious internal injury
- Handle bass with dry hands
- Drag fish across dry sand or excessively handle fish in a manner that removes their protective mucous coating.
- Kick or step on fish. You will damage their internal organs
- Touch the red gill rakers or gill area
- Gaff a fish you intend to release
- Release a fish without first resuscitating

Additional time should be taken resuscitating bass caught on light tackle as they tend to be at a greater level of stress due to the longer fight.

Fishing report from Dave Spendiff Oct 5, 2013.

Why does it always happen this way? You fish for fluke all summer, catch a bunch but not nearly as many keepers as you would like and then the season is over. You begin fishing for other "in season" species and what do you catch? You catch fluke, **BIG FLUKE!**

The past two weeks I've tried to catch weakfish using lures, a method I prefer over bait. I use light tackle and light line to get various sizes of soft jerk baits (finesse, Zoom fluke, shad, grubs) down in the water column. I've fished a 30' deep hole that come out of and flows up into 8-12' flats. So, I use various weight jig heads, from 1/4 - 1oz. to fish all depths and areas. On my first outing I caught 4 weakfish, keeping the first caught that was hooked deep, even though

a later fish was a bit larger. I weighed that fish in at Fisherman's Headquarters - 2.40lbs.

The next outing I took my neighbor who is not a lure fisherman. I rigged him up with a 7" finesse on a 1oz. jig head so that he would work the deeper sections of the drift... he caught 3 fluke over 4lbs. and we lost his biggest lifting it into the boat (no net!) when the snap failed, pulled straight. Had to be 7+lbs.!!! We also caught 2 blue fish and one weakfish that we didn't keep. Next trip yielded 1 blue fish, 1 weakfish, and a 6+lb. fluke that was weighed on my BogaGrip! The picture of that fish doesn't do it justice, but for perspective look at the tail compared to my foot.

The last trip started early as I wanted to fish the entire outgoing. I fished all morning with only a foul hooked spot to show for my efforts...it went in the live well, just in case I needed to start bait fishing. With about an hour left in the outgoing, I started to fish the flats. **WHAM!** A fantastic hit from what I thought was a bluefish until I got a glimpse of its tail, it was a really decent weakfish. Thank goodness I brought the net, it came aboard and the spot received his freedom. According to the a BogaGrip it weighed a tad over 6lbs. According to the Fisherman's Headquarter scale it weighed 6.50lbs.

After all is said and done, not a bad weakfish, but what about those out of season **FLUKE!**

In this situation we are using a [Shimano Sustain 5000](#) spool which holds 200 yards of 12 lb monofilament. and we want to use a 150 yard top-shot of 20 lb braided line.

 IS APPROVED AND AUTHORIZED BY THE
 NJ STATE POLICE MARINE SERVICES BUREAU

In New Jersey, all persons operating any powerboat or PWC (jet ski, sea doo, etc.) must
 have proof of passing an approved boating safety education course. All operators,
 regardless of age, must possess an approved boating safety education certificate.

GET YOUR NEW JERSEY BOATER CARD IN 3 EASY STEPS

1. Take and pass the New Jersey Boat Operator Online Boating Safety Education Course and print your "Proof of Completion" document.
2. Call and schedule an appointment to take the final exam at any our approved testing centers.
