### **THE LEGISLATIVE REPORT**

In my meeting on March 31st with the offices of Senator Menendez and Senator Booker and Congressman Pallone, I discussed beach replenishment and how that will impact

the recreational fishing community. I discussed how the notching of jetties will cut off access that anglers have used for over 100 years. There were no studies done on the jetties that were notched previously to determine if the Army Corp of Engineers' approach was appropriate. I was invited to a meeting in Congressman Pallone's office on April 16th but due to my schedule, Paul Haertel attended to represent Jersey Coast. His report is in the President's column.

### **Sand Mining**

The other problem I discussed with our congressional representatives was the proposal for sand mining and flattening the lumps. JCAA has fought this battle numerous times back as far as the late 80's. JCAA, American Littoral Society and Clean Ocean Action have worked together to stop this in the past and will do so again. It is important that you contact New Jersey DEP and the Governor's Office to register your objections. We need for Governor Christie and the DEP to publicly oppose sand mining on lumps. My understanding is that the DEP has not signed off on the permit. If my memory is correct, Governor Christie can veto the plans of the Army Corp of Engineers.

Ken Warchal from the Manasquan Marlin and Tuna Club first brought this to my attention and also pointed out the places in the document that I should look at. His remarks and the link to the document is below. If you have any problems send me an email and I will send you the PDF file.

Area B is the lump between the Axel Carlson and the beach. F2 is Manasquan Ridge. Here are some key points and the link for this proposal:

The current initial sand quantity required is estimated at 9,865,000 cubic yards, which is a reduction from the original plan quantity of 10,689,000 cubic yards. Periodic nourishment was increased from 961,000 cubic yards to 1,364,000 cubic yards, and is scheduled to occur every 4 years. **p.1 of interior cover**

For initial construction, material would be taken from the sand borrow areas identified as areas A, B, D, and E. Sand for periodic nourishment would be obtained from these four offshore borrow areas and potentially one that is currently being studied known as F2. **p.2 of interior cover**

This Draft EA is being forwarded to the U.S. Environmental Protection Agency Region II, the U.S. Fish and Wildlife Service, the National Marine Fisheries Service, the New Jersey State Historic Preservation Office, the New Jersey Department of Environmental Protection (NJDEP), and all other known interested parties for comment. **p.2 of interior cover**

The sand sources proposed in USACE (2002), Borrow Area A and Borrow Area B, were determined to be suitable based on their material grain sizes and lower impacts to fisheries resources. **p.2 of 3.0 Alternatives Considered**

Borrow Area B is located about 1.75 miles offshore of Mantoloking, NJ. This area is approximately 360 acres in size and contains approximately 7.5 million cubic yards of suitable beach fill material with a maximum disturbance depth of approximately -81 feet NAVD. **p.7 of 4.2.2 Borrow Areas**

As discussed in the Feasibility report, the Corps is also pursuing the use of Borrow area F2 as another potential source of sand for future periodic nourishments for the project area. Borrow area F2 is located about 4.6 miles offshore of Mantoloking and is approximately 1700 acres in size. **p.7 of 4.2.2 Borrow Areas**

Areas 5.6.3 Prime Fishing Areas  
Several locations within or near the project area are classified as Prime Fishing Areas (NJAC 7:7E-3.4) by NJDEP (Figure 9). One of these features lies within Borrow Area B and one lies within Borrow Area F2 (The Manasquan Ridge). These areas were originally delineated by Long and Figley (1984) in a publication titled New Jersey's Recreational and Commercial Ocean Fishing Grounds. **p.22 of 5.6.3**

### **Seismic Blasting**

### **Fishing Seasons**

In a nutshell, the seasons will be shorter or the size will be larger or the limit will be smaller for fluke and sea bass. Winter flounder, on the other hand, will have the season extended to a full year, with the same 2 fish and 12" limit. The exact details of all of these changes have not yet been approved in their final forms, but will be shortly.

Coast Guard announces Barnegat Inlet North Jetty repair project, safety zone

BARNEGAT LIGHT, N.J. — The Coast Guard is giving notice that the U.S. Army Corps of Engineers has contracted with Agate Construction to repair the Barnegat Inlet North Jetty beginning on or about April 14 and possibly continuing through November. Operations will occur during daylight hours and at night. A crane barge and a rock barge will be spudded down for stabilization at the north jetty with barge lights illuminated. The navigable channel in Barnegat Inlet is narrow due to shoaling on the south side and in the center. Natural changes in the inlet typically cause the water to be deeper on the north side, near the damaged jetty. The U.S. Army Corps of Engineers' Dredge, Murden, is dredging the shoal during the month of March to widen the navigable area. Depending on the results of this dredging, a safety zone will be activated that encompasses the entire Barnegat Inlet. Within the safety zone the following is not permitted: swimming, diving, fishing

**Update:** I was in a CG Aux meeting on Saturday, Commander Speers indicated that as of then, The barge(s) have not arrived to the inlet. It is his understanding that the barge(s) will be side by side with a tug along side of them. Boaters will be allowed to traverse the inlet single file in both directions. Any conflicts may arise when a commercial vessel will travel thru and have to have his outriggers in the down position. With that happening it will most likely take up the balance of inlet.

### **BoatUS Is Fighting To Make Sure Fishermen And Boaters Can Stay On Course**



At a hearing before the Subcommittee on Coast Guard and Maritime Transportation to review the future of the federal government's navigation programs and aids to navigation, BoatUS urged the federal agencies faced with lower budgets to keep the needs of recreational boaters in mind when looking at future savings and efficiencies.

Aids to navigation include items such as floating and lit buoys, fixed markers, sound signals and range markers that allow boaters to safely navigate.

"In an age of electronic communications and digital technology, I am interested in the savings and efficiencies that can be gained through an e-navigation system, as well as the progress we have made in implementing e-navigation," Subcommittee Chairman Duncan Hunter (R-CA) said. "However, I am also concerned that as an e-navigation system is built out, adequate redundancies and back-up systems are put in place to ensure safety."

BoatUS acknowledged that the U.S. Coast Guard's [aids to navigation](#) mission is understandably focused on supporting commercial shipping and fishing, but forgetting about the 12 million registered recreational boats could prove hazardous.

Unlike commercial vessels, recreational boats are much less likely to have sophisticated electronics needed to access some of the newer proposed systems such as virtual buoys. There is still a significant need for the physical aids to navigation in areas such as shallow draft harbors and channels where boaters operate.

Also commenting about the collection of data used to create nautical charts, BoatUS said there was a "backlog of need to survey areas with active recreational boating populations."

The national boat owners group also acknowledged and thanked NOAA's Office of Coast Survey for being responsive to boaters needs with a change in a plan that would not have included "the Magenta Line," or Atlantic/Gulf Intracoastal Waterways, on new charts. Instead, the Office has undertaken an innovative program that will use verifiable "crowd

source" information combined with survey data to maintain the Magenta Line.

## USING SABIKIS

### Tips for Sabikis

Looking to catch that monster snapper or grouper? Nothing beats dropping live bait such as pinfish or cigar minnow on a wreck. One of the easiest ways to catch live bait is on a sabiki rig. These rigs feature a lead line with additional branching line each having a hook. The lead line ends with a weight attached at the bottom. A sabiki rig typically has between 6 to 10 small hooks with a tiny piece of shiny of material attached to act as a lure to attract fish. The glimmer in the water as the rig is lowered resembles the tiny pieces of bait food fish typically eat. They are irresistible. To read more of Sabiki Rigs go to:



NJ STATE POLICE MARINE SERVICES BUREAU

In New Jersey, all persons operating any powerboat or PWC (jet ski, sea doo, etc.) must have proof of passing an approved boating safety education course. All operators, regardless of age, must possess an approved boating safety education certificate.

**GET YOUR NEW JERSEY BOATER CARD IN 3 EASY STEPS**

1. Take and pass the New Jersey Boat Operator Online Boating Safety Education Course and print your "Proof of Completion" document.
2. Call and schedule an appointment to take the final exam at any our approved testing centers.
3. Show your "Proof of Completion" document at the testing center along with a photo ID. The final exam must be taken in person and a passing score of 70% or better is required to obtain your New Jersey Education Certificate. *\$5<sup>00</sup> off Boater's safety course*
