Regulatory & Legislative Report June, 2017 By Dave Spendiff

N.J. fishermen make their case to feds as fluke battle rages on

BY MICHAEL SOL WARREN mwarren@njadvancemedia.com, NJ Advance Media for NJ.com With New Jersey's summer flounder fishing industry on the line, Garden State officials made their case to NOAA fisheries on Tuesday afternoon.

The summer flounder fishing season has been shortened by 25 days this year in order to meet a reduced quota imposed by regional fisheries officials.

In a hearing with the federal agency, New Jersey Department of Environmental Protection officials argued that the state's regulations for summer flounder (or fluke) fishing reach conservation equivalency with new federal regulations.

The cornerstone of New Jersey's argument: That the state's proposed regulations will actually preserve more of the summer flounder stock than the measures being put forth by the feds.

Tuesday's call was closed to the press, but in a statement following the call NJDEP spokesperson Bob Considine described it as a "good discussion." He added that New Jersey emphasized its plan would protect more breeding females, thus making a brighter outlook for the future of the fluke stock. The showdown between NOAA and New Jersey fishermen has been building throughout the spring. On June 1, the Atlantic States Marine Fisheries Commission declared New Jersey to be out of compliance with fluke regulations.

The dispute is now being considered by NOAA Fisheries, and U.S. Secretary of Commerce Wilbur Ross, for a final decision. If the out-of-compliance finding is upheld, a moratorium on fluke fishing in New Jersey could be instated until the state returns to compliance.

"We appreciated the opportunity to talk with New Jersey. Now that we've heard their thoughts, we'll be reviewing all the information," NOAA spokesperson Jennifer Goebel said in a

statement following the hearing NOAA Fisheries is expected to make a final decision by July 11, according to Goebel.

President Donald Trump has yet to nominate anyone for the NOAA administrator position, though AccuWeather chief executive Barry Myers is reported to be a frontrunner according to the Washington Post. The new federal regulations have also garnered attention from state lawmakers. New legislation was introduced in Trenton last week with the intention of extending benefits to fisherman feeling financial strain because of size restrictions placed on both summer flounder and black sea bass.

Assemblymen Bob Andrzejczak (D-Atlantic, Cape May and Cumberland) and Bruce Land (D-Atlantic, Cape May and Cumberland)



introduced Assembly Bill 4981, which would extend unemploymen t benefits to fishermen that are put out of work by the new regulations. Andrzejczak and Land were joined by Assemblyman Vincent

Mazzeo (D-Atlantic) to introduce Assembly Bill 4974, which would appropriate \$5 million from New Jersey's

General Fund to the New Jersey Department of Agriculture in order to provide financial assistance to fishermen affected by the new regulations.

Both bills are currently in the Assembly Appropriations Committee.

NOAA AFFIRMS NEW JERSEY'S CURRENT-SEASON SUMMER FLOUNDER LENGTH AND BAG LIMITS

DIVISION OF FISH AND WILDLIFE LAUNCHES OUTREACH CAMPAIGN TO EDUCATE ANGLERS ON KEEPING FISHERY SUSTAINABLE

(17/P73) TRENTON – The National Oceanic and Atmospheric Administration (NOAA) has affirmed New Jersey's summer-flounder fishing size, bag limits and season, meaning all rules adopted by the state earlier this year will remain in effect through early September, Department of Environmental Protection Commissioner Bob Martin announced today.

The decision, approved by U.S. Secretary of Commerce Wilbur Ross, finds New Jersey in compliance for management of summer flounder. It follows weeks of information-sharing between the DEP and NOAA about the expected impacts on New Jersey's summer flounder fishery imposed by a regional fisheries commission earlier this year.

"We are very pleased that NOAA worked with us to understand our position that sound science and good long-term planning must drive decisions about the management of summer flounder, one of the state's most important recreational and commercial fish species," Commissioner Martin said. "New Jersey is fully committed to employing science and public education to conserve a species that is critical to the fishing culture and economy of the state."

"I would like to thank Secretary Ross and Assistant Administrator of NOAA Fisheries Chris Oliver and for working with the State of New Jersey to preserve and manage our fisheries through responsible management processes, while recognizing the economic impacts of this industry to the state," said DEP Deputy Commissioner David Glass.

The decision from NOAA has be made and was just released

The decision means that the recreational summer flounder season, that began May 25 and runs through Sept. 5, remains unchanged. The minimum size remains 18 inches for summer flounder for most coastal waters, including the ocean, estuaries and creeks. Anglers in these areas may keep three legally sized fish per day. The size limit for Delaware Bay is 17 inches, with a three-fish per day limit. At Island Beach State Park the size limit for shore fishing is 16 inches, with a daily two-fish limit.

Toward the DEP's goal of ensuring a sustainable summer flounder fishery, the DEP's Division of Fish and Wildlife launched a campaign to educate the fishing public on how to reduce discard mortality by safely releasing summer flounder that do not meet minimum size requirements.

"We are asking all anglers to help protect this important species for future generations," Commissioner Martin said.

Recreational and commercial fishing generates \$2.5



billion in economic activity in the state each year. Also known as fluke, summer flounder is popular because of its delicate flavor and abundance along beaches and in bays and other

coastal waters.

The "If You Can't Keep It, Save It!" campaign focuses on the proper handling methods and gear to use to reduce unintentional mortalities that can occur when flounder that do not meet minimum length requirements are returned to the water.

The campaign builds upon the FishSmart campaign promoted by the National Oceanic and Atmospheric Administration. New Jersey's effort features distribution of print and electronic brochures to anglers registered through the state's Saltwater Registry, charter and party boat operations, bait-and-tackle shops and members of fishing organizations, as well as radio public-service announcements and newspaper advertisements. The Division of Fish and Wildlife is also doing outreach through its website, email lists and social media.

To make the "If You Can't Keep It, Save It!" campaign even more successful, the Division of Fish and Wildlife, in coordination with the American Sportfishing Association and Eagle Claw

Fishing, will distribute 20,000 free larger-sized hooks that help anglers land bigger fish and reduce the potential for discards.

These hooks will be available soon at bait-and-tackle shops. The Save the Flounder Fishery Fund provided valuable support to this effort. A list of participating shops will be made available on the <u>DEP's website</u> and the Division of Fish and Wildlife Facebook page.

The Division of Fish and Wildlife encourages anglers to follow these techniques:

- Plan ahead Expect to release fish and have the necessary equipment to do so, including de-hookers and proper nets; more experienced anglers may also consider using a recompression tool, a device that allows fish to be returned to the water at a safer depth.
- Use appropriate gear Use gear suited to the size of the fish that you are trying to catch; 5/0 to 7/0 size hooks are recommended to successfully land bigger fish and reduce discards.
- Handle fish carefully Use knotless, rubberized landing nets and rubberized gloves to avoid removing the protective slime layer on fish and help ensure survival when it is placed back in the water.

"By following these guidelines, anglers will be giving fish a better chance of survival," said Division of Fish and Wildlife Director Larry Herrighty. "This campaign reminds all generations of anglers that proper handling and quick return to the water will help ensure an ample supply of keepers for generations to come."

In February, the Atlantic States Marine Fisheries Commission (ASMFC), a regional board comprised of representatives from Maine to Florida, approved a 19-inch size limit for New Jersey. However, Division of Fish and Wildlife data show that few fish in New Jersey reach that size due to the species' biological needs and distribution patterns. Moreover, the overwhelming majority of fish that would meet that "keeper" size limit would be reproductive females.

New Jersey appealed the ASMFC decision to NOAA, expressing concerns that the larger size limit would result in a significant increase in discard mortalities and would make the population less sustainable by forcing anglers to keep reproductive females.





Keeping A Proper Lookout

The legal requirements and ramifications of COLREGS Rule 5.

In September 2015, a U.S. Coast Guard-licensed captain delivering a 60-foot boat from the Newport, Rhode Island, boat show to another boat show in Norwalk, Connecticut, ran over a small fishing boat, killing the lone occupant. After a trial this spring, the captain was found guilty of, among other things, failing to keep a proper lookout. He said at trial that he hadn't seen the 23-foot boat.

Often termed the first rule of seamanship, Rule 5 of the International Regulations for Preventing Collisions at Sea (COLREGS) expressly requires that "[e]very vessel shall at all times maintain a proper lookout by sight and hearing as well as by all available means appropriate in the prevailing circumstances and conditions so as to make a full appraisal of the situation and of the risk of collision." Here's a practical perspective to assist the recreational boater.

All mariners must utilize sight, sound, and all available means to monitor the presence and location of other vessels to avoid risk of collision, stranding, and other hazards to navigation. Courts have interpreted this to include the power and speed of your vessel, other vessels, prevailing weather and sea conditions, visibility, traffic density, proximity of navigational hazards, as well as other allision (running into something stationary) and grounding risks.

For a recreational vessel owner or operator who takes to the seas alone, complying with the lookout rule is not exactly as cut-and-dried as one may think. If a skipper decides to act as his or her own lookout, there must be an unobstructed view from the steering station, and there should be no conditions that would require a posted lookout, such as restricted visibility or a crowded waterway.

Courts have made it clear that a boat owner cannot turn control of his boat over to someone who may lack experience or may be intoxicated. If the boat is being operated jointly and a passenger maintains some active responsibility for and control over certain aspects of navigation, there still must be a clear delineation of duties with the lookout obligation always being assigned and satisfied. They have also consistently refused to recognize an exception to the lookout rule on account of size alone. One court found that a 36-foot sailboat owner was partially at fault for failing to maintain a lookout when an oceangoing container ship collided with his sailboat.

BoatUS - MMSI Registration

Take the search out of search & rescue!

Your VHF radio equipped with Digital Selective

Calling (DSC) is the single most important piece of

safety equipment you can have on board your

vessel.

About DSC

DSC allows the radio to transfer information digitally, not just by voice, and to instantly send a digital distress alert to the Coast Guard. Part of that alert is a nine-digit Maritime Mobile Service Identity (MMSI) number that identifies your boat. The MMSI number is a bit like a phone number for your boat, and all DSC capable equipment (including AIS units) associated with the specific vessel should use the same MMSI number, since the MMSI serves to identify the vessel, not the equipment. If you sell your boat, the MMSI number is normally transferred with it.

Without an MMSI, the digital functions on a DSC-equipped VHF radio will not function. The MMSI number must be registered in a database that is relayed to the Coast Guard for use in Search and Rescue. DSC-equipped radios also need to be interfaced with a GPS when they are installed so that your position will be sent with the emergency message in a distress situation.

Registration Criteria

BoatUS has been authorized by both the <u>Federal</u> <u>Communications Commission (FCC)</u> and the U.S.

Coast Guard to assign MMSI numbers only to vessels that meet the following criteria:

- Used for recreation only
- Not required by law to carry a radio
- Do not make international voyages or communications

Do NOT Register with BoatUS MMSI if:

- Your vessel is required to carry a radio onboard ("Compulsory Equipped")
- You plan to visit or communicate in a foreign port including Canada, Mexico, Bahamas, and the British Virgin Islands
 If either of the above conditions apply, you are legally required to obtain a Ship Station
 License from the <u>FCC</u>. They will issue an appropriate MMSI with the License.

NOTE: when traveling to foreign ports, you are required to have a Restricted Radiotelephone Operator Permit holder aboard.





HOW TO TIE MONO LEADER TO BRAID

ESSENTIAL SKILLS FOR EVERY ANGLER BY SWS STAFF OCTOBER 28, 2016



- 1. Tie a loop in the braid using a surgeon's end loop, spider hitch or Bimini twist, and lay the leader alongside the loop.
- 2. Pinch the leader and the end of the loop and wrap the leader around the doubled braid eight times, then bring the tag back through the braid loop.
- 3. Pull on the braid until the knot tightens and seats. Clip off the tag end of the mono.

Braided line and nylon or fluorocarbon monofilament seldom play well together with conventional knots designed for mono-to-mono connections. When connecting a leader to braided line for light-tackle fishing, this simple, secure connection does the job.
