#### 2018 NEW JERSEY MARINE FISHING REGULATION - Report by Phil Simon

On August 20 the Atlantic States Marine Fisheries Commission (ASMFC, responsible for regulations 0 – 3 miles from shore) and the MidAtlantic States Fishery Management Council (MAFMC, responsible for regulations from 3 – 200 miles, the exclusive economic zone EEZ) jointly announced the catch and landings limits for summer flounder, scup, black sea bass and bluefish for 2019. The commission's actions are considered final, but the councils still require higher level approval from NOAA. Noteworthy to the recreational fishing community, the recreational harvest limit for summer flounder was increased from the 2018 limit of 4.42 million pounds to a higher limit of 5.15 million pounds, in what seems like good news. However, NOAA is in the middle of a benchmark stock assessment for summer flounder, which will not be completed, and the results released until February of 2019. Depending on how that assessment shakes out, we could see significant alterations to the summer flounder harvest limits as the winter progresses into spring. Especially problematic for us are the new sets of data emerging from the revised fishing effort methods implemented by the folks at the Marine Fisheries Information Program (MRIP), which indicate that the old telephone surveys underestimated fishing effort (number of individual person fishing trips) by three- to eight-fold. As the recreational catch is calculated by multiplying the fishing effort times the catch rate (fish caught per angler), we can expect some lively discussions about just what the recreational catch numbers really are, and the impact on past and current stock assessments.

As we heard from Jim Hutchinson Jr Managing Editor for The Fisherman at last month's membership meeting, there is a reasonable chance that the summer flounder fishery could be declared overfished with overfishing occurring, which would trigger (as defined in the Magnuson-Stevens act) a rebuilding program for summer flounder. Interim stock estimates for summer flounder have been declining for the last 5 years or so, apparently caused by poor recruitment of new fish into the stock. With recreational and commercial landings of summer flounder already at near historical lows, its hard to see how the regulators should expect that tighter regulations are going to have any significant impact on stock levels. Oh Boy! We will keep an eye on this as the winter progresses.

The new catch limits for scup and bluefish are basically unchanged from 2018, but black sea bass was reduced from 3.66 to 3.27 million pounds. Needless to say, the yelling and screaming about black sea bass will continue, as the stock is well above its threshold target levels for being declared overfished, and no one seems to know how to deal with the fact that the catch numbers are high because there are so many fish around, especially in the northern range of the stock.

A recent proposal to turn over a portion of the recreational bluefish quota (which has been historically underused) to the commercial side appears for now dead in the water.

A benchmark stock assessment for striped bass is also underway, with results to be published in 2019. Right now, no one is expecting big changes, but again we will have to keep an eye on this. There could be some impact from the revised MRIP numbers here as well.

For those interested the council and commission will be holding a hearing at 6pm on Monday September 24 at the Ocean County Administrative Building (101 Hooper Avenue, Toms River) to gather public input on a proposal to reallocate the commercial summer flounder fishery based on the fact that the stock has moved north since the last state allocations were set. While not directly impacting the recreational harvest numbers, these proposed changes could impact who is catching the commercial quota and where they operate from.

I attended the recent "Stakeholders Participation Day" at the annual meeting of the American Fisheries Society held in Atlantic City. This meeting brings together thousands of fishery academic researchers, government regulators and scientists, and commercial representatives over a five day period to attend lectures, scientific presentations, and workshops on various aspects of marine and freshwater fishery science. This opportunity provided recreational and commercial fisherman who would not normally attend the 5-day meeting (daily registration was in the \$100s) an opportunity to attend for one day for a reduced rate of \$50. A few takeaways from the meeting: (1) fish stocks of interest to us, especially summer flounder and black sea bass, are continuing to show a northeast shift in the stocks, most likely due to changes in ocean temperature; (2) new approaches to monitoring fish behavior and location are revealing we know a lot less about where and why fish go where they go than we thought; (3) the regulatory councils and commissions, forced to "do something" about falling fish stocks, only have the tool of regulating harvests, even if the causes of declines are unrelated to fishing.

They ended up with 5 keepers with the largest at 20 ½".


