DECEMBER MEETING - Due to the Community Center (CC) closure on Veterans Day, our November meeting had to be moved to December. Since the CC closes early December for staging holiday toys and clothes, our only location for the meeting is in the smaller building off on the right. However, since the Auxiliary Coast Guard has the room for the second Friday of the month, our final 2022 meeting will be on the first Friday, December 2nd.

There will not be a speaker but last year, Phil Simon put together a collection of the photos submitted throughout the year. I sent Phil all the photos and he added some captions to make an enjoyable recap of the year. Feedback from everyone was great and we will do it again this year! **Oh and yes there will be pizza for all to enjoy!** Please come out and enjoy the presentation and the good natured banter along with a few slices. Depending on the turnout, we may be a little cramped but come on out!

NEW JERSEY JCAA & FISHING REGULATIONS by Phil Simon - As I predicted last month, the Atlantic States Marine Fishery Commission (ASMFC) decided not to make any changes to the quotas for Striped Bass for 2023, as the current rebuilding plan seems to be on track to rebuild the stock by 2029, as required by the Magnusen-Stevens legislation. Of course we will have to see what the NJ Marine Fisheries Commission eventually decides to do on the local size and bag limits, but again I do not anticipate much change if any.

On Tuesday and Wednesday Nov 15 and 16, the Mid Atlantic Chapter of the American Fisheries Society held its annual meeting in Asbury Park. I attended the meetings to see what was happening regarding issues of interest to the recreational fishing community. This is a meeting of academic, government, and other scientists and students, mostly from Rutgers U., Stockton U., the U. of Delaware, some of the NOAA labs, the wind farm companies, and even some high school students. Data from quite a few research projects was presented, both orally and at a poster session. Here are just a few of the things I learned that I thought might interest you:

1. There are a fairly large number of research projects being established to monitor the impact of the offshore wind farms on the ecology off the coast of NJ. However, I asked two of the wind farm representatives who gave talks what they were prepared to do if the results of those studies showed significant damage being produced to the coastal fish stocks. They squirmed! Should the first of the 300+ turbines that will be installed (off Atlantic City to start) a) cause changes to the migration of fluke larvae into the estuaries, b) cause changes to the cold pool that forms each spring and summer, c) redirect the

- striper migration, or d) who know what else! There is no plan in place for where the scientists would take their findings, nor any indication that any negative data would ever cause any change to the installation of the rest of the turbines. The wind farm companies have focused most of their spin doctors on the commercial scallop and ocean clam draggers in terms of where they place the turbines and have actually given much less thought to concerns of the recreational community, or in fact to the concerns of the fisheries scientists. The current approach seems to be to build the turbines first, then let's see what happens. What could go wrong with that!
- 2. I'm sure most of you know that the green crabs that we use for tog fishing are in fact an invasive species from Europe and have been having a rather negative impact on local competitive species. Did you know that they have also invaded the west coast, and are now causing a threat to several fisheries in Alaska? I did not. Did you know that our blue crabs have invaded the Mediterranean, and have caused panic over there, as they are equally damaging to the ecology there, killing other commercial fish and crabs, destroying fishing nets, and destroying the local plant life. However, some of the fishing communities have caught on that money can be made by switching from net fishing for finfish to cage fishing for blue crabs, and there is a growing new business there. Spain and Tunisia both are making the change. Tunisia has already implemented a regulatory harvest program to prevent overfishing, so as not to lose their newfound industry. Speaking of blue crabs, the climate change-induced warming of the oceans that we are already seeing should be favorable for the expansion of the range for blue crabs, but a study from New York shows that their harvest of blue crabs has been in serious decline now for several years. Overfishing may be the culprit, but the data is not conclusive.
- 3. As we know the Atlantic Striped Bass stock has been under severe strain for years now, and the current tight regulations are the result of management attempts to fix the problem. Did you know that the forage species that stripers eat (including not just bunker, but also fish such as American Shad and River Herring) are also in need of stock rebuilding? Both stripers and forage fish are under the preview of the ASMFC, and they have separate teams working on their respective management plans. Some not-so-new data were re-presented at this meeting showing that in the Delaware River, when striper numbers are up, the shad numbers are down, and visa versa, suggesting that the goals of "restoring" both types of fish are in conflict. When stripers are present in large numbers, they decimate the shad population. In my opinion the best way to fix this problem is to re-open the many rivers along the coast that were dammed up in the eighteenth and nineteenth centuries, allowing both types of fish to have more areas to breed and thrive. What's stopping us? Money and politics, as usual.
- 4. When it comes to keeping us happy regarding summer flounder bag and size limits, things are just fine, yes? Okay, so maybe not. Some of the scientists have been looking for ways to re-adjust the size limits or find a way to catch more males so as to reduce the selective harvest of females that the current regulations are causing remember

that 95% of the summer flounder over 18" that we catch are females. If we could catch more large males, maybe this would help. Unfortunately, it turns out that there are plenty of large males, but they tend to stay out in the deeper waters where we don't normally fish for summer flounder. So it's not just the regulations, but the natural behavior of the flounder population that is causing the selective harvest we see. Better use of the slot fish approach might be an answer to our inability to take home a fish to eat, but the number crunchers tell us that this will cause us to go over our quota. In my opinion the only thing that is going to improve the recreational summer flounder fishery in the short term is to put further restraints on the commercial boats that drag their way through the offshore grounds during the winter, and that's not likely to happen. Remember though that we are fighting the climate change- induced shifting of the fluke biomass north and east, which means more trips to Montauk and the Nantucket Shoals if you want to stock up on fluke filets or catch that big one.

- 5. Did you know that scientists can now extract DNA from the water and tell us what fish are present and possibly how many? Studies are underway to see if this can supplement the costly trawl surveys that are conducted to estimate the size of our fish stocks.
- 6. Northern Snakeheads, an invasive Asian fish species I thought was a problem for the southern US, are in fact moving north, and are now in Delaware, NJ, and NY. Maybe you knew this already? If you catch one, kill it, don't throw it back.

SURF FISHING by Ed Valitutto - This year's LBI Surf Fishing contest continues through December 11th with several prizes still available. Full prize details, tournament rules and daily weigh-ins are on their website The LBI Fall Classic. I've been on the sand six or so times and all I've caught are dogfish! But not so for Weighmaster Pat Presutto. Pat has three in the box at last count, several released and he isn't finished! Pat fishes on several LBI beaches driving



his truck wherever he has buggy permits. Enjoy his photos on the next several pages.


