

NEW JERSEY REGULATORY NEWS by Phil Simon - "How did we get here?" This is a two-part article on recent developments in the regulation of several of the fisheries of interest to us as recreational fishermen. In this first part, I describe what is happening, and my views on the causes of the problems that we are experiencing. In the second part (October Newsletter), I will focus more on the issues with Atlantic Striped Bass, and some possible solutions for the long term.

At the recent meeting of the Mid Atlantic Fisheries Management Council (MAFMC) in Annapolis MD, a joint session to set the specifications for the years 2026 and 2027 was held with the management board for Bluefish, and for the combined management group of Summer Flounder, Scup, and Black Sea Bass, which shared with the Atlantic States Marine Fisheries Commission (ASMFC). ASMFC handles fish stocks from 0 to 3 miles off the coast, while the MAFMC does the job for stocks 3 to 200 miles out. Joint custody of regulation of some stocks that cross the 3-mile line are handled by joint boards with members from both the Council and the Commission. The goal was to set the numbers for both the Commercial Quotas and the Recreational Harvest Limits (RHLs), i.e. how many fish can we keep.

On the surface the outcome appears to be good for all of us, with substantial increases in recreational and commercial harvest limits for Summer Flounder, Scup, and Black Sea Bass. (Bluefish are still subject to a rebuilding program, where liberalization is more controlled.) And yet there was an undercurrent of pessimism with the recreational harvest future, with a sense that the new higher limits would not get translated into higher bag limits or relaxed size limits or seasons. Apparently, there are no such worries regarding the commercial numbers. Final recreational specifications will be made in November, after reviews of the data and process by additional committees, including the Advisory Panels of which I am a member. However, I am

pretty sure that unless there is some intervention from forces outside the normal Council/Committee system, Summer Flounder, Scup, and Black Seabass will see no increases in their recreational harvest limits, Bluefish will continue to be highly restricted, and we may well see new plans to impose no-targeting closures on Atlantic Striped Bass.

So how can it be that the scientists now believe that liberalization of our recreational harvest is now recommended for several of the species, but it's likely that we will not see any increase in our catch. This is a complex situation, with multiple issues and a fair amount of subjective opinion on my part, but in my view here are the major culprits:

- 1. Commercial and Recreational harvest numbers are managed differently. Commercial landings are managed by direct reporting of the offloads from the fishing vessels at the docks. Disregarding for the moment the possibility of illegal fishing, accounting for the number of fish removed from the water is relatively straightforward, at least for the management teams. Recreational harvest is much more difficult, as there is no practical way to count the number of fish brought home by thousands of individual recreational fishermen. Thus, the management people must rely on indirect methods to estimate our removals and as we shall see this causes more grief than we deserve.
- 2. Let's start with the Marine Recreational Information Program, MRIP, which is the process that attempts to count both the number of recreational trips taken (the Fishing Effort Survey, FES), and the kinds and numbers of fish caught by individual fishermen, via Dockside Surveys. While both parts of this program have been subject to revisions and overhauls over the years, it is the FES that has become a real thorn in the side of the recreational sector. Revamped from a random telephone survey to a mail survey in 2018, the MRIP team reported that the new method for the FES was showing that the recreational sector was catching way more fish than indicated by the old FES. In some cases, the increases were astounding, with up to eight times as many fish being caught according to the new numbers. Without blinking, the ASMFC and the MAFMC accepted the new estimates without question. Even more astounding, they decided that the numbers justified revisions to the stock sizes as well. In the case of summer flounder, the stock size was re-estimated and increased based on the new MRIP numbers as were the Commercial quotas and recreational RHL, but the recreational increase was then negated because the new numbers showed we were catching more than our RHL; so no increase for us.

Panic followed with other stocks with the revised numbers that were generated by the "New MRIP". It was determined that Bluefish were now being overfished, and a rebuilding program was instituted along with a reduction of the recreational bag limit from 10 fish to 3. Normally, when you change methodology and get dramatically different data, you step back and attempt to determine why the new data is so different, before you institute the


new methodology. Not so here, it was full steam ahead. We are only now finding out that the new FES survey has been systematically overcounted by 30% and higher, with devastating impact on all the subsequent regulations derived from this faulty set of data. (A classic case of Ready, Fire, Aim) The current buzzword is that the FES needs "recalibration", maybe to be done for 2027. In my view, mail surveys have clearly shown to be a poor choice to generate data that is reliable, and the MRIP team should look at revamping the entire approach.

3. Estimates of catch and stock size have varied considerably from year to year, resulting in sometimes significant swings in determinations of RHLs, and yearly changes in the regs. To smooth out the process so that swings would not be as drastic, a new system was added to the recreational regulation setting process four years ago. The Percent Change Approach attempted to base bag and size limits not solely on the hard numbers of the previous year's catch, but on other factors including state of the stock and the longer-term trends of the stock. While implemented with the best of intentions, it quickly turned out that no matter what, the results always came out with decreases in catch. No matter how big the stock grew, more cuts were indicated. It got so bad that for Black Sea Bass, the parent group to the MAFFC and the ASMFC, the Greater Atlantic Regional Fishery Office, GARFO, had to intervene last year to keep cuts from being implemented (the Science and Statistical Committee, SSC, also played a role in calling for cuts, more on that in a moment).

Some improvements were implemented to the Percent Change Approach at the end of 2024, but it looks like we will still see the process call for no change or even cuts to fisheries where the overall safe catch level has been raised significantly. We could again see increases in commercial catch with decreases in recreational catch. (No wonder I heard some of the comments from the Commercial reps to the MAFMC saying how they think the Percent Change Approach was "really working pretty well"). I'm guessing GARFO may be needed to fix things yet again, if the Council does not figure out how to deal with this nonsense, or even the commerce secretary, as we have seen in other instances in the past, might be asked to override the Council. Fishermen vote, yes?

4. As a group, fisheries managers tend to be conservative in their approach to fisheries management. And who can blame them? No one wants to be responsible for the collapse of an economically (and politically) important stock of fish, such as what occurred with the Atlantic Cod, so they tend to be cautious in allowing any sort of liberalization when it comes to setting catch limits. The scientists on the Science and Statistical Committee have shown a similar trend, often falling back on computer models and statistics when the answers these tools provide appear to be wrong. Just put up a complex algorithm and computer projection showing future stock declines, and who is

going to challenge you? An egregious example of this can be seen with the management of the Black Sea Bass fishery; the red lines on the chart below show the periodic predictions of stock decline, which never materialized, while the stock continued to grow and grow. It now stands at 2.8 times its target level.



Have you wondered why we kept seeing cuts to our catch while the stock was two to three times above its target? This is why. Projections by the scientists of crashing stocks caused the managers to tighten up the recreational catch. The good news is that the SSC has finally figured this out and are now backtracking on many fronts. Witness the recommendations from the SSC to increase Bluefish, BSB, Scup, and SF at the August MAFMC. The bad news is that these increases may not be turned into actual changes to our catch allowances, due to the questionable data and decision-making tools of MRIP and the Percent Change Approach. The people responsible for developing and implementing these tools have invested their careers in their efforts and will not give them up without a fight. We will have to raise our voices whenever possible to help ensure that the Commission and the Council and their various boards come to the proper decisions.

Next month I will continue with more details on Atlantic Striped Bass, including the issues surrounding poor recruitment numbers, and the resulting drive to further limit recreational and commercial harvest of these gamefish.

having a good time fishing. Sunsets and the like are OK, but people are what most folks want to see (especially if it's a picture of themselves and their family). Here's last month's winner:




Bill Bond, Pat Presutto and Glen Minor joined John Stuebing on a Tuna trip.

NEW JERSEY MARINE COUNCIL MEETING by John Stuebing - On September 6^{th,} I attended the New Jersey Marine Council Meeting in Manahawkin. There were many topics discussed but I am only going to summarize a few key topics that I think affect most of us.

Blue Crabs: If you like crabbing and are using non collapsable pots, there are changes coming to the NJ regulations. You are allowed two traps with a non-commercial license. These traps must have a line and buoy attached with your CID number on the float. In addition, the trap itself must have a tag affixed with your CID number. These requirements apply to traps soaking in open water or secured to a dock, pier, jetty, etc. The question was asked; if crabbing from your bulkhead or floating dock (at your residence), do these regulations apply. Answer: YES! There will also be revisions to the terrapin excluders on these traps. They cannot be bigger than 6" by 2" and must be applied to every tunnel.

Croakers: Without going into a lot of details, NJ may be required to establish bag and size limits for next season. The Council has requested the Technical Committee (TC) to research what other states are doing.

Bluefish: It is estimated that the stock is not at the target levels but it is not overfished. As a result, the NJ commercial harvest level (CHL) will be increased by 50% and the recreational harvest level (RHL) will be increased by 40%. Most likely the changes for the recreational angler will be an increase in bag limit from 3 fish to 5 fish. Season and size limits (currently no size limit) will remain the same.

Black Sea Bass: The Bio-Mass is at twice the target and is not being overfished. For next year the CHL will be increased by 30%. It is expected that the RHL will be increased but it is unclear by how much. Why is that? I will briefly discuss in the Fluke Section. Several council members are floating the idea of an earlier start date (5/1/26) instead of increasing bag limits.

Summer Flounder (Fluke): Oh boy, hold on to your hats. We are at 83% of the Bio Mass target. It is estimated that we are not over fishing. The harvest levels will be increased for 2026 – for some people. As of this writing the CHL will be increased by about 38%. The RHL *may* not get any increase at all. Why? It is due the methodology that is being applied. Currently, a method referred to as "Percent change" is being used. Based on this method the results of multiple years are combined. That means in bad times the harvest reductions are not as drastic and in good times, liberalization of regulations is less. In this particular case, the numbers are right at the point where under this method, the recreational side of the fishery will not get any increase.

This started a spirited conversation between the Council and members at the TC. This is, in fact, a transfer of quota from the recreational side to the commercial side. Keep in mind that currently the commercial side gets 55% of the harvest and the recreational side gets 45%. The council asked the TC to examine options to get around this. There is big concern that the Public will not understand why this is happening. The representative from the TC explained to the council that there is no possibility that there will be a change in methodology between now and time the

regulations have to be set. The only hope we have at this time is a change in the estimates. If between now and the time regulations have to be set (December), the estimates of the size of the Bio Mass increase from 83% to 90% of target, there may be some room for increases in the RCL. I would not bank on it....

Striped Bass: I am not going into a lot of detail here. Phil has already updated everyone on what is going on. Everything that was discussed leads me to believe that there will be closures in 2026. There is a lot of fighting between the states about when the closures take place. As it is at this time, regardless of when the closures take place, New Jersey takes the brunt of the harvest reduction (12%). There is also a debate about "No Target" and "No Harvest". This entire situation is a complete mess. I asked the council and attending members of TC to explain "No Target". Specifically, how is it defined and how will it be enforced? They could not answer. The chairman, Dr Pat Donnely, finally told me they have no idea.

The committee passed a motion to write a letter to the ASFC (Atlantic States Fishery Commission) recommending we maintain a status quo for 2026 based on potential economic hardship and other factors.

After the meeting,me and the representative from JCAA met with the lead representative from TC. I asked if we could implement closures at our discretion (for New Jersey). I was told that may be possible. One solution may be to implement a closure starting in June or July and another closure in December. That may have the least impact on the B&T stores and Charter businesses. We will have to see where this goes.

Enforcement: It was reported that there were 50 summonses written in the last two months for Blackfish alone. Some of those summonses were for possession of more than 40 fish. The council finally had enough. They are forming a committee to lobby with members of the State Legislature to form a separate Fish & Game Court. If successful the summonses would not get adjudicated in Municipal Courts that are overwhelmed. The goal is to start enforcing the fines. I hope they are successful.

A drop between the index finger and thumb works great. I get a secure grip on the leader and can twist as much as I want. I included a picture of the bottle. It sells on Amazon for around \$14.00. STEAMED CLAMS & MUSSELS from OTW Magazine -



I saw this recipe in OTW and thought this classic seafood dish is both simple and satisfying. Use whatever mix of clams and mussels just enough to pile into a big bowl, tear up some crusty bread, and dig in.

Definitely add your own extras like chopped tomatoes, hot peppers and herbs.

Feel free to send me your favorite recipe!

Ingredients

- 2–3 lbs fresh shellfish (mussels, littlenecks, steamers, or a mix)
- 1-2 tablespoons olive oil
- 1 small onion, chopped
- 4 cloves garlic, chopped

- 4 tablespoons unsalted butter
- 1–2 cups white wine
- 1–2 cups water
- Crusty bread, for serving
- Optional: fresh parsley, lemon wedges

Instructions

- 1. Prep the Shellfish. Rinse the clams and mussels under cold water, scrubbing the shells and discarding any that are cracked or won't close when tapped.
- 2. In a large pot over medium heat, add olive oil, chopped onion, and garlic. Cook, stirring, for 2–3 minutes until the onions are slightly softened and fragrant. Add the butter and stir until melted.
- 3. Dump the rinsed shellfish into the pot. Pour in the white wine and water (use more or less depending on how much broth you want), and cover tightly with a lid.
- 4. Increase heat to high and steam until all the shells have opened. Clams take a little longer than mussels so put them in first. Give the pot a shake halfway through to help everything cook evenly. Discard any unopened shellfish.
- 5. Ladle the shellfish into wide bowls, spoon over the broth, and serve with toasted bread to soak up the liquid gold at the bottom. Garnish with chopped parsley and a squeeze of lemon if desired.
