PRESIDENT'S MESSAGE

Hello VHFC Members.

Fall officially arrived on Monday, September 22 but strong winds and rain kept most folks at home until this past weekend. Let's hope the weather cooperates as our fall fishing season gets into full swing. The low number of FOM entries and no submitted Member Reports this month indicate the limited fishing due to the weather and it was sad to see the fluke season end on September 25th. Oh well, that's typical September weather but at least we have been fortunate to avoid any direct hurricane impact - at least so far. But remember, the Atlantic hurricane season isn't officially over until November 30th so we have a long way to go!

As for fishing, Sea Bass opened October 1st but strong winds kept folks from venturing out for the first few days but that is over for now. See my report for Friday the 3rd and I'm sure more reports will follow as the fish are hungry. Just a reminder, Sea Bass is 10 fish @ 12.5" for October but jumps to 15 fish for November & December. Blackfish have been showing at the

Barnegat Light bulkhead and jetties with lots of shorts to devour your crabs and sand fleas. I haven't had a keeper after several tries but have watched three keepers caught next to me by folks doing the same thing! As the waters cool, more Tog will show up and fishing will only get better. Tog is a one fish limit now but will increase to 5 fish on November 16.

Bluefish have been scarce but they are definitely present in the inlet (Bayside Dave caught one on a popper) and a few are being caught on bait off the beach. Their numbers should also increase as the bait migration gets going. Speaking of the bait migration, my lagoon still has peanut bunker swirling around but while fishing off the Barnegat docks, I have seen large schools of peanuts, spearing and what looked like mullet. The mass exodus south can't be far off! I can also tell you for sure that Striped Bass are definitely in our area. Ken Chew caught one a few weeks back off the BL bulkhead on a sand flea and I caught several bonus fish on Friday using Spot near the lower end of Oyster Creek. I also spoke with a seasoned angler on the bulkhead who said he had several large Stripers swirling below his short Tog.

While many club members still have their boats in the water, there are plenty of alternatives if that is not an option for you. Party boats, charters and surf fishing offer great opportunities for having fun fishing in the fall. One of the best things about post Labor Day 'down the shore' besides the nice weather and warm water, is the lack of people and car / boat traffic. So make the most of it and enjoy this great time of year. As always,please be sure to share your reports for fellow club members. Hope to see you this Friday!

NEW JERSEY REGULATORY NEWS by Phil Simon - Atlantic Striped Bass Addendum III Although the official public comments period for this measure ends October 3, I'm providing the club with some background, as well as a copy of the letter sent by the club to the ASMFC. The Atlantic Striped Bass Management Board, (the Board) a component of the Atlantic States Marine Fishery Commission (the Commission), has responsibility for monitoring and regulating the striped bass stock along the east coast. At the end of October, the Commission will vote on whether to adopt a new set of regulations, designated "Addendum III to the Atlantic Striped Bass Fishery Management Plan" (the Addendum) regarding the commercial and recreational fisheries for striped bass for 2026 and beyond. In 2019 the Commission adopted severe restrictions to recreational striped bass harvests because of the new data from the overhauled Marine Recreational Information Program. This was on top of significant cutbacks to the recreational harvest in 2018.

The new data in 2019 resulted in the formal declaration that the stock was overfished, which required the implementation of a stock rebuilding program. The terms of the Magnusen-Stevens legislation that regulates marine fishing in the USA requires that the stock must be rebuilt to its specified "Target" level within 10 years, i.e. the end of 2029. In 2023 the Commission, on advice from the Board and their Technical Committee (TC), declared an Emergency with respect to the rebuilding program because the data and projections from the TC indicated that the target stock level would not be met under the regulations in place at that time. Thus, we ended up where we are now with the one fish limit with a slot of 28" to 31".

In 2024 based on new projections, the TC again proposed that an "Emergency" be declared, as their data indicated that the target was still not reachable by the end of 2029 and calculated that an additional cut of 12% from the recreational and commercial harvest would be necessary. They originally wanted an 18% cut, but that was scaled back. But cooler heads prevailed, and

the decision was made to follow the Addendum Process, which was to be completed within 2025.

Here is the letter we sent:

Subject: Comments on Draft Addendum III (to the Atlantic Striped Bass FMP)

Although the Addendum includes measures on commercial tagging, items specific to the Maryland fishing seasons, and standardization of striped bass length measurement, the focus of these comments is specifically on the proposal for a 12% cut to the recreational harvest. The Commission is now proposing to use seasonal closures, including no targeting measures, on top of the already highly restrictive one slot-fish approach, which has already severely curtailed recreational fishing. We are opposed to the Commission taking any further cuts in the RHL for striped bass and would recommend on this issue that you **keep the status quo for the recreational RHL**, for the following reasons:

- The cuts made in 2018, 2019, and 2023 have been sufficient in reversing the downward trend in the female Spawning Stock Biomass (SSB), and the most recent data shows a steady upward trend in the stock. (See Figure 1 in the Addendum). Likewise, fishing mortality has been reduced below the threshold (Figure 2). The stock is not overfished, and overfishing is not occurring.
- In our opinion, contrary to the interpretation by the TC and the Board, the odds highly favor the restoration of the SSB by 2029 (Figure 3). The curve crosses the target line at 2029 well within the 95% CI. Considering the uncertainty of the stock assessment process, and the known errors of the MRIP process for estimating recreational catch, the 30% odds seem highly questionable. Remember, MRIP numbers drove the TC to revise their spring estimate of needing only a 1% reduction to the current estimate of 12%.
- Relying on recruitment patterns and trends to set regulations for fishing is problematic. It is known that there is little to no mathematical direct correlation between the female SSB and recruitment patterns for most of the species under management by the Commission and the Council. Furthermore, we would challenge the TC to prove that the current level of recruitment is incapable of supporting the SSB at its current level. Threshold and Target values for Atlantic Striped Bass were set in 1995, when the stock was declared rebuilt, and the conditions in the estuaries supported a higher level of recruitment. Conditions have deteriorated due to climate change and human development of the watersheds, and the SSB has now apparently stabilized to a new range, a "new normal". Trying to restore

- recruitment and the SSB to 1995 levels may be an exercise in futility, unless there is remediation issues underlying poor recruitment (see below)
- Key numbers that went in to the TC's and Board's projection regarding the rebuilding will be changing in 2026 and 2027. It has now been established that the Fishing Effort Survey (FES) portion of the MRIP process is severely flawed, and that a recalibration will almost certainly revise the historical recreational catch numbers, including the ones that triggered the 2019 rebuilding program. In addition, a new stock assessment workshop will be conducted in 2027, which may better clarify the status of the stock. It seems prudent to wait on making more decisions costly and damaging to the recreational and commercial communities before we see just how the new numbers develop.

There are, however, some things that we all should be supporting that could significantly improve recruitment and the SSB for the future that do not involve more cuts in the RHL. These include the following:

- Coastwide declaration of Atlantic Striped Bass as a gamefish, as has already been done in New Jersey. Legal and illegal commercial killing of stripers is almost certainly occurring at a higher level than the currently estimated 10% levels of total harvest. Underreporting of dead discards, unreliable weight and size estimates, and other misrepresentations are suspected, and if nothing else, should be investigated and remediated.
- Establishment of a stocking program for Atlantic Striped Bass for more coastal
 estuaries (as has already been implemented to restore the stock in North Carolina)
 should be further considered. Costly, yes, but it should work, as it has for other stocks.
 Creeks and rivers where dams have been removed, and where there were once
 populations of Atlantic Striped Bass, should be at the top of the list for any new efforts.
- Support efforts and legislation to control the Blue Catfish population in the Chesapeake and elsewhere that they are becoming established. Their impact on the YOY surveys could be huge.
- Get control of the Menhaden commercial fishery. Now.

As the saying goes, if all you have is a hammer, everything looks like a nail. Pounding away at the recreational harvest via seasonal closures is not the only tool we have available and is probably not going to do much to solve recruitment problems. Seasonal closures will do severe damage to the for-hire portion of the recreational sector, and to businesses and facilities that support recreational fishing, including boatyards and bait and tackle stores. And it will further the decline in recreational saltwater fishing generally. We do need to ensure that there are enough stripers to go around, but the Commission and the Board have already reduced the RHL to a point where further reductions to recreational harvest have little chance of making an impact on the SSB. Fix the real issues as best we can, and we might see an improved SSB for years to come.

The bottom line. We support:

- 1. Measuring Total Length: Option B. Makes perfect sense.
- 2. Commercial Tagging: Option C. B is also acceptable.
- 3. Maryland Chesapeake Bay Seasons: Option B. C is unnecessary.
- 4. Reduction in Fishery Removals: Option A, Status Quo. No Reduction. For all the reasons stated above. Commercial reductions could be addressed with greater enforcement to stop illegal fishing and catch misrepresentations. Commercial tagging reform is a start.
